FIRST AMENDMENT TO AGREEMENT NO. 24449

24449

THIS FIRST AMENDMENT TO AGREEMENT NO. 24449 is made and entered, in duplicate, as of November 14, 2006, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on November 14, 2006, by and between the CITY OF LONG BEACH, a municipal corporation ("City"), and the LONG BEACH UNIFIED SCHOOL DISTRICT OF LOS ANGELES COUNTY, a public school system created and authorized by the California Constitution and the City Charter ("District").

WHEREAS, the parties entered Agreement No. 24449 dated as of March 19, 1996, for reciprocal use of facilities for educational, community recreational and civic activities; and

WHEREAS, District desires to extend the term of said Agreement in order to continue usage of facilities and City is willing to so extend;

NOW, THEREFORE, in consideration of the mutual terms, covenants and conditions contained in Agreement No. 24449, the parties agree as follows:

1. Section 17 of Agreement No. 24449 is hereby amended in its entirety to read as follows:

"17. TERM. The term of this Agreement shall commence on January 1, 1996, and shall terminate at midnight on December 31, 2007, unless sooner terminated as provided herein. Either party may terminate this Agreement by giving ninety (90) days prior notice to the other party."

2. Except as expressly amended herein, all of the terms, covenants and conditions of Agreement No. 24449, as amended and to the extent not contrary to this First Amendment, shall remain unchanged and in full force and effect.


