

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DESIGNATING THE BALLOT LISTING OF THE CANDIDATES WHICH HAVE BEEN NOMINATED FOR THE SPECIAL MUNICIPAL ELECTION ON TUESDAY, APRIL 14, 2015

WHEREAS, in accordance with the Long Beach City Charter, the City Council has called a special municipal election for Member of the City Council for Council District Four, to be held in the City of Long Beach Councilmanic District 4 on April 14, 2015; and

WHEREAS, in accordance with City Charter Section 1907, the City Clerk has submitted to the City Council a certified list of the candidates which have been duly nominated as required by law for the elective office to be voted on at said election, and the names are listed for each such office in the order of the randomized alphabet selected by the Secretary of State in a drawing held on January 20, 2015, pursuant to California Elections Code Section 13113;

5 Section 2. The City Clerk shall cause the list of nominees to be published
6 in accordance with California Elections Code Section 12110 and California Government
7 Code Section 6066.

8 Section 3. This resolution shall take effect immediately upon its adoption
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
