- 3. Credit due the agency for the deletion of the planned Hydro-seeding, requested by the Department of Parks Recreation and Marine, as directed by the Project Engineer, for the lump sum credit of......<\$20,000.00>
- 4. Credit due the agency for the deletion of contract Bid Item No. 22 Solar Powered emergency phones at the unit cost of \$7,530.00 Each (2/EA @ \$7,530.00/EA), requested by the Department of Telecommunication, as directed by the Project Engineer, for the estimated credit of<\$15,060.00>
- 5. Provide all labor materials and equipment to install two (2) fixed line emergency phones in lieu of the planned Solar Powered emergency phones, requested by the Department of Parks Recreation and Marine, as directed by the Project Engineer,
