RESOLUTION NO. RES-07-0019

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO ENTER INTO PHOTOCOPIER LEASE AND SERVICE AGREEMENTS THROUGH THE CONTRACT BETWEEN THE COUNTY OF SAN BERNARDINO, CALIFORNIA AND KONICA MINOLTA BUSINESS SOLUTIONS USA TO PURCHASE PHOTOCOPIER AND COPIER SERVICES FOR THE DEPARTMENT OF LIBRARY SERVICES

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to lease copier equipment and purchase copier service from Konica Minolta Business Solutions USA; and

WHEREAS, San Bernardino County, California has a contract for the lease and purchase of photocopier and copier services under Contract No. 06-261 ("San Bernardino Contract"); and

WHEREAS, City's participation in the San Bernardino Contract will facilitate acquisition of photocopier and related services as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the San Bernardino Contract, considerably more funds would be required; and

WHEREAS, the City Council approved such participation on September 19, 2006 by adopting Resolution No. RES-06-0111, but the cost of participating was thereafter

determined to have been calculated incorrectly and has since been revised;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated hereby by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized to enter an agreement with Konica Minolta Business Solutions USA to lease photocopier and purchase related services of the same type and kind purchased by San Bernardino County, California pursuant to the San Bernardino Contract except as modified by mutual agreement of the City of Long Beach and Konica Minolta Business Solutions USA and the lease and purchase by the City of Long Beach shall be on the same terms and conditions afforded to San Bernardino County, California in a net amount not to exceed \$137,500 per year plus an additional 2% of that base amount if needed for unforeseen expenses, for a period extending until the warranty on these items expires.

Sec. 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
