A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH DECLARING THE RESULTS OF THE SPECIAL MUNICIPAL ELECTION HELD IN THE CITY OF LONG BEACH, CALIFORNIA, ON TUESDAY, NOVEMBER 5, 2019, FOR THE PURPOSE OF ELECTING A CANDIDATE FOR THE OFFICE OF MEMBER OF THE CITY COUNCIL FROM THE FIRST COUNCILMANIC DISTRICT; AND DIRECTING THE CITY CLERK TO ISSUE A CERTIFICATE OF ELECTION TO THE CANDIDATE DECLARED TO HAVE BEEN ELECTED AT THE SPECIAL ELECTION

WHEREAS, the City Council of the City of Long Beach did, by Resolution No. RES-19-0100, declare a vacancy in the Office of Member of the City Council for the First Councilmanic District, and did duly call and provide for the holding of a Special Municipal Election on Tuesday, November 5, 2019, for the purpose of electing a candidate for the Office of Member of the City Council for the First Councilmanic District; and

WHEREAS, the election was held in the City of Long Beach in the First Councilmanic District on that day; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk duly canvassed the returns of the election and has transmitted the results to the City Clerk;

NOW, THEREFORE, the City Council of the City of Long Beach does resolve, determine, order and declare as follows:

Section 1. That the Special Municipal Election for the purpose of electing a candidate as required by law for the Office of Member of the City Council, First

1 Councilmanic District, was duly held on Tuesday, November 5, 2019, and the votes cast,  
2 including the absent voter ballots issued in connection with the election which were  
3 returned at the time and in the form and manner required by law, were all duly and  
4 regularly canvassed. That the Los Angeles County Registrar-Recorder/County Clerk has  
5 duly canvassed the returns of the election for a Member of the City Council and filed his  
6 Certificate of Canvass with the City Council and from that certification and return the City  
7 Council finds that the total number of votes cast in the district, the total number of votes  
8 cast in each of the respective election precincts established for the election, the number  
9 of votes cast for each candidate in each precinct and the total number of votes for each  
10 candidate are as provided in Exhibit "A" attached to and made a part of this resolution.

11 Section 2. That the candidates were nominated as required by law for  
12 the Office of Member of the City Council from the First District, and the names of the  
13 persons voted for at the election, were:

26 Mary Zendejas is declared elected to the Office of Member of the City Council from the  
27 First District for a partial term commencing December 3, 2019 for the remainder of the  
28 term of office terminating on the third Tuesday of December 2022. The City Clerk is
