FIRST AMENDMENT TO AGREEMENT NO. 29242

THIS FIRST AMENDMENT TO AGREEMENT NO. 29242 is made and entered, in duplicate, as of October 27, 2006 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on July 11, 2006, by and between the CITY OF LONG BEACH, a municipal corporation ("City"), and BEING ALIVE LONG BEACH, INC., a California corporation, doing business as BALB, whose address is 500 East Fourth Street, Long Beach, California 90802 ("BALB").

WHEREAS, City requires the assistance of a local community service agency to provide HIV case management services; and

WHEREAS, it has been ascertained that BALB is willing and able to provide said services required by City at a reasonable cost; and

WHEREAS, City desires BALB to provide said services for City, and BALB is willing to do so;

WHEREAS, the parties desire to extend the term of the Contract and provide for compensation during the extended term;

NOW, THEREFORE, in consideration of the terms and conditions contained in the Agreement and this Amendment, the parties agree as follows:

- 1. Section 1 of Agreement No. 29242 is hereby amended in its entirety to read as follows:
- "1. The original term of this Agreement shall commence at 12:01 a.m. on March 1, 2005 and shall terminate at midnight on February 28, 2006. The extended term of the Agreement shall commence at 12:01 a.m. on March 1, 2006 and shall terminate at midnight on February 28, 2007."
- 2. Section 2 of Agreement No. 29242 is hereby amended in its entirety to read as follows:
 - "2. BALB shall provide HIV/AIDS prevention case management and

City shall pay BALB for such services not to exceed Sixty Nine Thousand, Five Hundred Forty Two Dollars (\$69,542). During the extended term, City shall pay BALB an amount not to exceed Sixty Nine Thousand, Five Hundred Forty Two Dollars (\$69,542). Payment by City is contingent on receipt by City of monies from the County of Los Angeles and on satisfactory performance, in City's sole opinion, of work by BALB under this Agreement."

Except as set forth in this First Amendment to Agreement No. 29242,
all terms and conditions of the Agreement are ratified and confirmed and shall remain in full force and effect.
