#### **RECOMMENDATION:**

Receive the supporting documentation into the record, conclude the hearing and approve one of the following actions be taken: 1) grant the Permit, with or without conditions; or 2) grant a One-Year Short-Term Permit, with or without conditions; or 3) deny the Permit on the application of S.C. Fish Grill, LLC, DBA Khoury's Restaurant, 110 Marina Drive, for Entertainment With Dancing by Patrons at an existing Restaurant. (District 3)

#### **DISCUSSION**

The Long Beach Municipal Code (LBMC) requires an application be filed and a hearing be held before the City Council whenever this type of activity is requested and before an entertainment permit is granted or denied.

The LBMC also requires that the City Council make a determination that the application is complete and truthful; the applicant, the person interested in the ownership and operation of the entity, and the officers and trustees of the entity are law-abiding persons who will operate and conduct the business activity in a lawful manner; and, that the public peace, welfare, and safety will not be impaired. If this is so, the application shall be approved, a short-term permit shall be approved, or the application shall be denied.

Attached for your review is the application from S.C. Fish Grill, LLC, DBA Khoury's Restaurant. Also attached are reports from various departments and a summary of those reports, as well as the license history of the establishment.

City departments have conducted their investigation in accordance with the LBMC. The following summarizes their findings:

• The Police Department recommends that the permit for entertainment with dancing by patrons be denied. Based on the Vice Section's investigation and East Division's recommendation, along with opposition from the Marine Department, the Police Department has found the public peace, safety and welfare would be impaired by the issuance of this permit. - The Fire Department recommends that the permit for entertainment with dancing by patrons be approved.
- The Health and Human Services Department finds that the building/location meets department requirements for the proposed use with the condition that the establishment remain in compliance with the Long Beach Noise Ordinance (LBMC Chapter 8.80).
- The Development Services Department recommends that the permit for entertainment with dancing by patrons be approved.

In the event that any of the recommended conditions attached to any permit or licenses are in conflict, the permittee shall adhere to the strictest of the applicable conditions. This location has been licensed as a restaurant with alcohol since March 1997.

This matter was reviewed by Deputy City Attorney Cristyl Meyers on November 20, 2008.

#### TIMING CONSIDERATIONS

The hearing date of December 16, 2008 has been posted on the business location, with the applicant and property owners within 300 feet notified by mail.

#### FISCAL IMPACT

The following fees were collected with the application: Building Review \$20 and Zoning Review \$14 (Development Services Department), Police Investigation \$1,000 (Police Department), Temporary Permit \$300, Labels \$90 (Financial Management Department), and Health/Noise Control \$94 (Health and Human Services Department).

The following fees will be collected if the application is approved: Business License \$325.85 and Regulatory \$875 (Financial Management Department).

- 2.3 Name. The name of the Company is <u>S.C.FISHGRILL</u>, and all business of the Company shall be conducted under that name or under any other name but, in any case, only to the extent permitted by applicable law.
- 2.4 Term. The Company shall be dissolved and its affairs wound up in accordance with the CA LLC Lew and this Company Agreement on <u>Dec 31, 2035</u>, unless the term shall be extended by amendment to this Company Agreement and the Articles of

The Police Department recommends **DENIAL** of this application for an Entertainment with Dancing Permit, by S.C. Fish Grill, LLC, dba Khoury's Restaurant, located at 110 Marina Drive. This recommendation is based on increased calls-for-service, incidents and arrests attributable to the business, a recommendation from the East Division Patrol Commander, objections from the Marine Department, and non-compliance by ownership to resolve issues of concern.

#### **Background**

Khoury's Restaurant is located at the south end of the Alamitos Bay Marina. The establishment serves a seafood menu for lunch and dinner. After food service ends, the business becomes a nightclub with limited food service. Khoury's is a for-profit corporation, owned and operated by James Kim. The business currently holds a Type 47 (On Sale General Eating Place) Alcoholic Beverage Control license. On October 16, 2007, Long Beach City Council approved a one-year short-term entertainment permit. On September 3, 2008, Khoury's applied for a new Entertainment with Dancing permit, requesting live amplified music, a disc jockey and karaoke music.

#### Crime Analysis

As part of the investigation, Vice Detectives examined calls for service, crime reports, and arrests at the above location for a two-year period from May 2, 2005 to May 2, 2007. The report indicated fifty-one (51) calls for service, twenty-two (22) incidents, and nine (9) arrests, attributable to the business. Compared to the last analysis, during the previous entertainment application, the figures have doubled. Approximately half of the calls-for-service, incidents, and arrests are related to minors being present and underage drinking at the location.

#### **Patrol Division**

East Division Patrol Commander Cynthia Renaud was contacted for an opinion regarding the issuance of this permit. She said there have been numerous fights at the establishment over the last year, and the owner does not have control over his patrons. She said many of the problems have been related to minors being allowed to enter the location and consume alcohol. She said there is also a lack of security in the parking lot that has contributed to some of the problems. Commander Renaud is opposed to the issuance of an entertainment permit for Khoury's.

#### Vice Investigations

#### **Entertainment Permit Inspection**

On Tuesday, September 23, 2008, detectives responded to the business and observed no residences within 100 feet of the business. Detectives met with Salim Khoury, Khoury's manager, to discuss their current and approved conditions of operation. He was advised that calls-for-service and other incidents have doubled over the last year, and there appears to be an issue of non-compliance with the condition that excludes minors after 10 p.m. Mr. Khoury stated he was not aware of the restricted hours for minors and the additional security requirements. Mr. Khoury said he would make the necessary corrections and would abide by all approved conditions.

#### Marine Department Observations

Detectives spoke with Marine Department Officer Joe Johnson regarding the Khoury's business. He said over the past year that minors have been observed in the parking lot with alcohol. There have also been numerous fights in the parking lot at closing time. Many problems at the location appear to be related to minors being present and underage drinking.

#### <u>Undercover Police Investigations</u>

On Saturday, September 27, 2008, at approximately 2230 hours, detectives went to the location. Security guards were in the parking lot and at the front door checking identification. There were approximately 30 patrons inside the business drinking alcoholic beverages and listening to a live band. There did not appear to be anyone under 21 years of age inside the business.

On Thursday, October 9, 2008, at approximately 2230 hours, detectives went to the location. Security guards were in the parking lot and at the front door checking identification. There were security guards inside the business and at the back door as well. There were approximately 20 patrons inside the business listening to a live band, dancing, and drinking alcoholic beverages. There did not appear to be anyone under 21 years of age inside the business.

On Friday, October 10, 2008, at approximately 2300 hours, detectives went to the location. Security guards were in the parking lot and at the front door checking identification. There were security guards inside the business and at the back door as well. There were approximately 40 patrons inside the location listening to a live band, dancing, and drinking alcoholic beverages. Detectives also sent three minor decoys to the front door to see if they would be allowed to enter the business. The security guards checked their identification and noted they were under 21 years of age. A security guard inquired if they knew anyone inside the business and almost allowed them to enter. However, the minors were turned away when they did not provide security with proper information.

#### Recommendation

#### ENTERTAINMENT WITH DANCING AT KHOURYS RESTURANT 110 MARINA DRIVE Page 3

Khoury's current one-year short-term entertainment permit was approved on October 15, 2007. The permit was approved with a condition that would exclude minors (anyone under 21 years of age) from being inside the business after 10 p.m. There were also conditions requiring security in the parking lot and on the boat dock located to the rear of the business. For unknown reasons, the ownership and management of Khoury's did not abide by these conditions. As a result, calls-for-service and other incidents have doubled over the last year, and the business has become a burden on Patrol Division resources. With or without specific conditions to mitigate problems, the ownership and management have been aware of the current problems related to minors, but have made no attempt to resolve these issues.

Based on the Vice Section's investigation and East Division's recommendation, along with opposition from the Marine Department, the Police Department has found the public peace, safety, and welfare would be impaired by the issuance of this permit. Therefore, the Police Department recommends **Denial** of the requested Entertainment Permit.

The Community Design and Development Division of Department of Development Services has the following comments:

A review of the permit history for 110 N. Marina Drive, indicates that one Conditional Use Permit Exemption (Case No. 39-96) was approved for alcohol sales with meals only at an existing restaurant with a legal, nonconforming fixed bar. No CUPs or AUPs were found for the subject property.

The subject property is located within the Long Beach Marina Planned Development District (PD-4). Within PD-4, dancing by patrons is permitted as an accessory use for a restaurant.

The proposed dance floor will be located in the bar area of the restaurant. Per the Zoning Code, the parking requirement for a bar/tavern is 20 spaces per 1,000 square feet of gross floor area (GFA). The parking requirement for dancing by patrons is 25 spaces per 1,000 square feet GFA. The proposed dance floor measures 196 square feet. Given the difference in parking requirements, one additional parking space is required. The restaurant is located in a shopping center with nearly 400 on-site parking spaces available. In addition, the shopping center is immediately adjacent to public parking lots serving the marina and other coastal activities. As there is ample parking available for this use, the one additional required parking space can be accommodated and no additional parking is required.

Planning Bureau recommends that the entertainment permit with dancing for "Khoury's Restaurant" be approved.
