1 FIRST AMENDMENT TO AGREEMENT NO. 32184

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32184 is made and
4 entered, in duplicate, as of May 30, 2012, for reference purposes only pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on April
6 19, 2011, by and between P.I.E. MANAGEMENT, L.L.C., a Michigan limited liability
7 company ("Consultant"), with a place of business at 155 Riverview Drive, Anaheim Hills,
8 California 92808, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with temporary staffing services ("Project"); and

11 WHEREAS, the parties entered Agreement No. 32184 whereby Consultant
12 agreed to provide such services; and

13 WHEREAS, the parties desire to extend the term of the Agreement;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
15 conditions in Agreement No. 32184 and herein, the parties agree as follows:

16 1. Section 2 of Agreement No. 32184 is hereby amended in its entirety
17 to read as follows:

18 "2. TERM. The term of this Agreement shall commence at midnight on
19 May 29, 2011, and shall terminate at 11:59 p.m. on May 28, 2013, unless sooner
20 terminated as provided in this Agreement, or unless the services or the Project is
21 completed sooner. The parties have the option to renew this Agreement for one (1)
22 additional period.

23 2. Except as expressly modified herein, all of the terms and conditions
24 contained in Agreement No. 32184 are ratified and confirmed and shall remain in full
25 force and effect.
