### ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY ADDING SECTION 16.52.2280 RELATING TO THE DESIGNATION OF THE "FLY DC JETS" SIGN LOCATED AT 3860 N. LAKEWOOD BOULEVARD AS A HISTORIC LANDMARK

The City Council of the City of Long Beach ordains as follows:

Section 1. Section 16.52.2280 is added to the Long Beach Municipal Code to read as follows:

16.52.2280 The Fly DC Jets Sign.

- Pursuant to the provisions of Chapter 2.63 of the Long Beach Municipal Code and with the August 8, 2016 recommendation of the Cultural Heritage Commission, the City Council designates the following object as a Long Beach local historic landmark: The Fly DC Jets Sign. The Fly DC Jets Sign is located at 3860 N. Lakewood Boulevard; however, the landmark designation applies to the sign only, not the property or building on which it is located.
- The complete location, legal description and reasons for historic landmark designation are more fully contained in Resolution No. RESwhich shall be recorded pursuant to Public Resources Code 5029, Government Code Section 27288.2 and Chapter 2.63 of the Long Beach Municipal Code.
