WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed professional engineering services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34185 (the "Agreement") whereby Consultant agreed to provide these specialized services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to add \$2,000,000 to the Agreement for a total not to exceed amount of \$5,000,000; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on January 1, 2016, and shall terminate at 11:59 p.m. on December 31, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The parties have the option to extend the term for one (1) additional one-year period".
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34185 are ratified and confirmed and shall remain in full force
