1 WHEREAS, on July 19, 2022, the City Council authorized increasing the
2 aggregate not to exceed amount and extended the term to August 31, 2023, for as-needed
3 construction management and inspection services for all public works projects created
4 under Specification No. RFQ PW16-115; and

5 WHEREAS, the Parties entered into a Fifth Amendment to extend the term
6 of the Agreement to August 31, 2023, and update the City Representative; and

7 WHEREAS, on June 6, 2023, the City Council authorized extending the term
8 of the Agreement to August 31, 2024, for as-needed construction management and
9 inspection services for all public works projects created under Specification No. RFQ
10 PW16-115; and

11 WHEREAS, the Parties desire to extend the term of the Agreement by one
12 (1) additional one-year term;

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
14 conditions herein contained, the Parties agree as follows:

15 1. Section 2 of the Agreement is hereby amended to read as follows:

16 "2. TERM. The term of this Agreement shall commence at midnight on
17 August 31, 2016, and shall terminate at 11:59 p.m. on August 31, 2024, unless sooner
18 terminated as provided in this Agreement, or unless the services or the Project is
19 completed sooner."

20 2. Except as expressly modified herein, all of the terms and conditions
21 contained in Agreement No. 34390 are ratified and confirmed and shall remain in full force
22 and effect.
