A RESOLUTION ORDERING THE VACATION OF A
PORTION OF MAPLE WAY BETWEEN LONG BEACH
BOULEVARD AND ALAMO COURT IN THE CITY OF LONG
BEACH, COUNTY OF LOS ANGELES, STATE OF
CALIFORNIA

WHEREAS, the City Council of the City of Long Beach, did heretofore, on
October 1, 2019, by Resolution No. RES-19-0146, declare its intention to order the
vacation, pursuant to the provisions of the Public Streets, Highways, and Service
Easements Law, a portion of Maple Way between Long Beach Boulevard and Alamo
Court, in the City of Long Beach, County of Los Angeles, State of California, as described
on the attached Exhibit "A", and as shown on the attached Exhibit "B", each incorporated
by reference; and

WHEREAS, the City Council did, at said time, fix Tuesday, November 12,
2019, at the hour of 5:00 p.m., as the time and the Civic Chamber, City Hall, 411 West
Ocean Boulevard, in the City of Long Beach, California, as the place for hearing for all
persons interested in or objecting to the proposed vacation to appear and be heard; and

WHEREAS, notice of the resolution of the intention to vacate, stating the
time and place of said hearing, was duly posted in the manner prescribed by law; and

WHEREAS, said hearing was called and held before the City Council at the
time and place so fixed and evidence taken and received on the matter of said proposed
vacation, and the City Council, upon said evidence, now makes those findings of fact set
forth in said Exhibit "B", attached hereto and by this reference made a part hereof;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as
follows:

BEGINNING AT THE SOUTHEAST CORNER OF SAID LOT 28; THENCE WESTERLY ALONG THE SOUTH LINE OF SAID LOT 28, SOUTH 89° 59' 23" WEST 2.00 FEET TO A POINT ON A LINE PARALLEL WITH AND 2.00 FEET WESTERLY OF THE EAST LINE OF SAID LOTS 14, 16, 18, 20, 22, 24, 26 AND 28; THENCE NORTHERLY ALONG SAID PARALLEL LINE NORTH 00° 00' 33" EAST 210.10 FEET TO A POINT ON THE NORTH LINE OF SAID LOT 14; THENCE WESTERLY ALONG SAID LINE, SOUTH 89° 58' 56" WEST 2.00 FEET TO A POINT ON A LINE PARALLEL WITH AND 4.00 FEET WESTERLY OF THE EAST LINE OF SAID LOTS 2, 4, 6, 8, 10 AND 12; THENCE NORTHERLY ALONG SAID PARALLEL LINE, NORTH 00° 00' 33" EAST 149.98 FEET TO A POINT ON THE NORTH LINE OF SAID LOT 2; THENCE EASTERLY ALONG SAID NORTH LINE NORTH 89° 58' 36" EAST 4.00 FEET TO THE NORTHEAST CORNER OF SAID LOT 2; THENCE SOUTHERLY ALONG THE EAST LINE OF SAID LOTS 2, 4, 6, 8, 10, 12, 14, 16, 18, 20, 22, 24, 26 AND 28, SOUTH 00° 00' 33" WEST 360.09 FEET TO THE POINT OF BEGINNING.



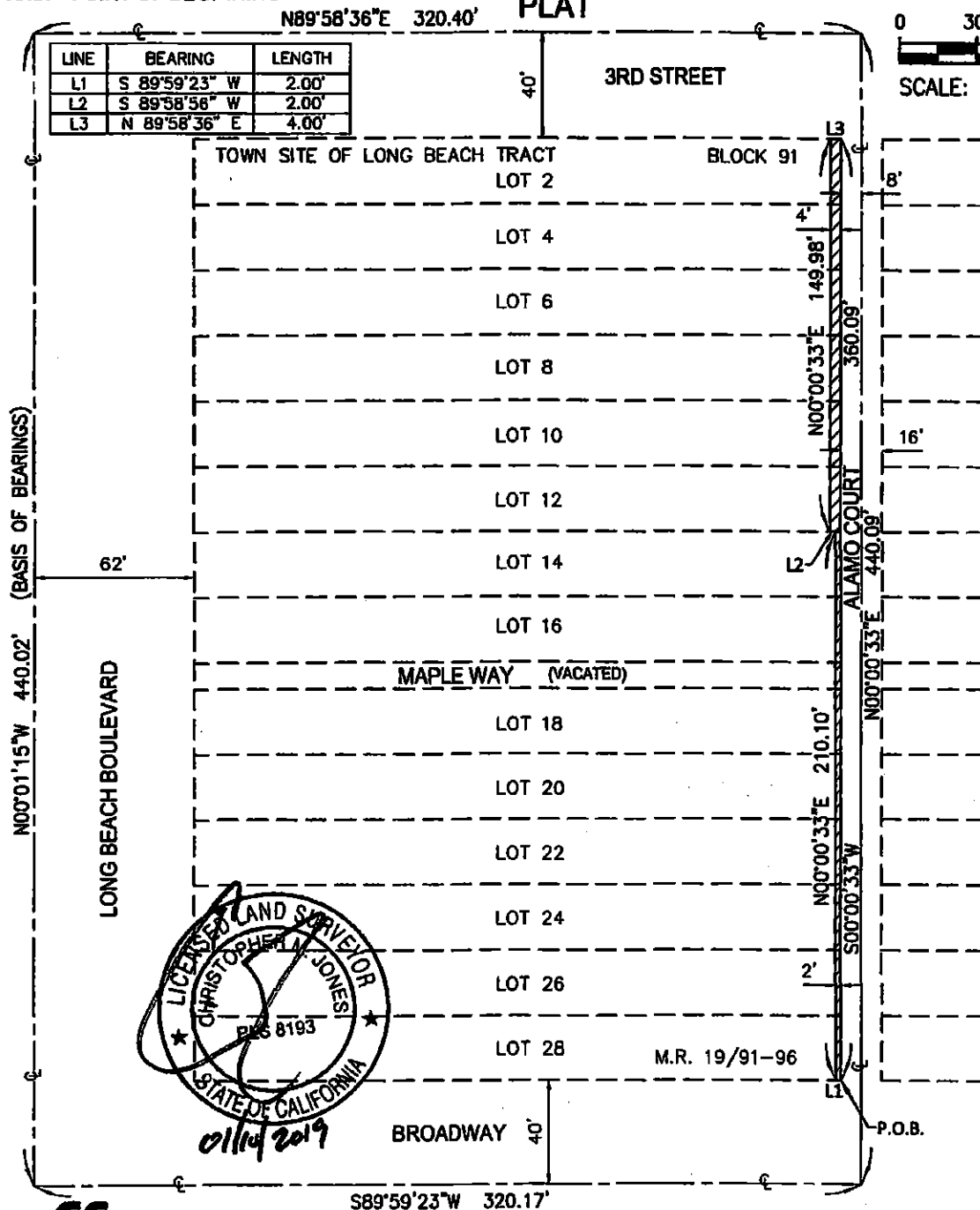

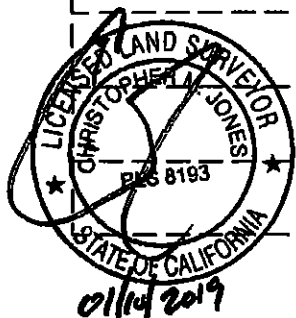

CITY COUNCIL FINDINGS

VACATION OF A PORTION OF MAPLE WAY BETWEEN LONG BEACH BOULEVARD AND ALAMO COURT Reference Sketch No. 1026 (V)

1. The subject right-of-way is unnecessary for present or prospective public use.

This finding is based upon the following subfindings:

- a) On June 6, 2019, the Planning Commission determined that the subject vacation is consistent with the General Plan, as required in Section 8313 of the Public Streets, Highways, and Service Easements Vacation Law.
- b) Those findings listed in the City Council letter dated November 3, 2009, agenda item 16.
- c) The rights-of-way would not be useful for exclusive bicycle pathway purposes.

2. The vacation of said right-of-way will not have a significantly adverse environmental effect.

This finding is based upon the following subfindings:

- a) The right-of-way is not and will not be needed for public use.
- b) In conformance with the California Environmental Quality Act, an addendum to the City of Long Beach Downtown Plan Program Environmental Impact Report (EIRA-02-17) was prepared for this project.
