FOURTH AMENDMENT TO AGREEMENT NO. 35750 35750

THIS FOURTH AMENDMENT TO AGREEMENT NO. 35750 ("Amendment") is made and entered, in duplicate, as of January 20, 2023 ("Amendment Effective Date") for reference purposes only, pursuant to Chapters 2.69 and 2.85 of the Long Beach Municipal Code, by and between HEALTHVANA, INC., a Delaware corporation ("Contractor"), with a place of business at 7162 Beverly Blvd., #238, Los Angeles, CA 90036, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 35750 (the "Agreement") whereby Contractor agreed to provide COVID-19 test patient results reporting services; and

WHEREAS, pursuant to Resolution No. RES-20-0092 the Parties entered into a First Amendment to the Agreement to extend the Agreement for another term and increase the contract amount.

WHEREAS, pursuant to Resolution No. RES-20-0092 the Parties entered into a Second Amendment to increase the annual contract amount by \$934,800, for a total not to exceed contract amount of \$1,800,000; and

WHEREAS, pursuant to Resolution No. RES-20-0092 the Parties entered into a Third Amendment to extend the term of the Agreement to January 31, 2023; and

WHEREAS, the Parties desire to extend the term to February 28, 2023 pursuant to Chapter 2.85 of the Long Beach Municipal Code; and

WHEREAS, on March 10, 2020, the City Council of the City of Long Beach recognized that an emergency did exist and unanimously passed a Resolution ratifying the City Manager's Proclamation of a Local Emergency and the Public Health Officer's Declaration of Local Health Emergency; and

WHEREAS, pursuant to Chapter 2.85 of the Long Beach Municipal Code, the City Manager and Purchasing Agent have the authority to approve purchases, rentals, or 1

- Except as expressly modified herein, all the terms and conditions contained in Agreement No. 35750 are ratified and confirmed and shall remain in full force and effect.
- 3. This Amendment may be executed in counterparts, each of which is deemed an original, but all of which constitutes one and the same agreement. Delivery of an executed counterpart of this Amendment electronically shall be as effective as delivery of an original signed counterpart of this Amendment.
