



SUBJECT: Agreement with Rebuilding Together Long Beach To Fund a Mobile Home Health & Safety Repair Grant Program for Extremely-Low Income Mobile Home Owners with \$172,096 from the Housing Trust Fund (Citywide)

RECOMMENDATION:

1. Approve a grant of up to \$172,096 in Housing Trust Funds to Rebuilding Together Long Beach for the creation of a Mobile Home Health & Safety Repair Grant Program for extremely low income mobile home owners;
2. Authorize the President to negotiate a Grant Agreement with Rebuilding Together Long Beach; and,
3. Authorize the President to execute any and all documents necessary to implement the Agreement.

DISCUSSION

Rebuilding Together Long Beach (RTLB) is a Long Beach based 501(c)(3) non-profit organization whose mission is to bring volunteers and communities together to improve the homes and lives of homeowners in need. RTLB has over 20 years of experience performing home repair services to lower-income households. Since 1992, they have rehabilitated over 250 homes in Long Beach and neighboring communities. Additional information about the organization is attached (Attachment A).

In the spring of 2015, Rebuilding Together Long Beach submitted a proposal to administer a Pilot Mobile Home Health & Safety Repair Grant Program(Program), which would provide rehabilitation assistance to extremely low-income mobile home owners. The repair services included in the proposed Program includes installing handicap/accessibility enhancements, such as wheel-chair or other access ramps, grab bars, lever door handles and faucets; installing seismic straps and relief valves on water heaters; installing smoke and carbon monoxide alarms; energy efficiency upgrades

such as caulking windows, re-hanging doors, upgrading or replacing electrical service systems, repairing or replacing roofs, and upgrading or replacing plumbing and HVAC systems; mitigating mold and re-plastering where needed; replacing rotted wood on sub floors, porches, and stairs; installing GFI receptacles where needed; and other health & safety related repairs as needed based on each applicant's rehabilitation work write-up. It is anticipated that each grant would range from \$2,500 to \$11,000 and would receive final approval by City staff prior to commencement of work. A summary of the proposed Program is attached (Attachment B).

There are currently funds available in the Housing Trust Fund (HTF), which was established on June 20, 2006 when the City Council approved Ordinance ORD-06-0021. The Ordinance requires that, to the greatest extent possible, 50% of the funds deposited into the trust fund be used to provide housing assistance to above moderate income households, and the other 50% be used to serve extremely low income households. A total of \$344,192 has been deposited into the HTF, including interest. Two second mortgage assistance loans totaling \$122,493 were previously provided to above moderate-income homebuyers (35.6% of HTF deposits). The current balance in the HTF is \$221,699. Based on the income-targeting requirement of the Ordinance, a total of \$172,096 (50% of HTF deposits) must be spent to assist extremely low-income households, and the remaining \$49,603 (14.4% of HTF deposits) can be spent to assist above moderate-income households.

In addition to the \$172,096 in LBCIC grant funds, RTLB will provide additional resources in the form of donated materials and both skilled and unskilled volunteer labor. RTLB anticipates that, as a result of their ability to leverage additional resources, the proposed LBCIC investment will translate into an estimated economic impact of between \$220,000-\$245,000.

In the past, the City and LBCIC have operated a Mobile Home Rehabilitation Loan Program funded with HOME and CalHome funds. Due to severe cutbacks in HOME funding, and reductions in staffing, the program has not been offered for the past three years. In addition, staff feels that a grant program would be more appropriate than a loan program to assist mobile home owners, since it is difficult to secure and collect on mobile home loans.

The proposed Program will provide an opportunity to assist vulnerable and extremely low-income mobile home owners who do not have the resources to address health and safety issues in their homes. The Program will also implement Program 3.1 d (Mobile Home Repair Grant) of the City's Certified Housing Element. For these reasons, staff supports and recommends approval of this proposal.

OUR FOCUS



Summary of Mobile Home Health & Safety Repair Program

The repair services proposed by Rebuilding Together Long Beach (RTLTB) includes installing handicap/accessibility enhancements, such as wheel-chair or other access ramps, grab bars, lever door handles and faucets; installing seismic straps and relief valves on water heaters; installing smoke and carbon monoxide alarms; energy efficiency upgrades such as caulking windows, re-hanging doors, upgrading or replacing electrical service systems, repairing or replacing roofs, and upgrading or replacing plumbing and HVAC systems; mitigating mold and re-plastering where needed; replacing rotted wood on sub floors, porches, and stairs; installing GFI receptacles where needed; and other health & safety related repairs as needed based on each applicant's rehabilitation work write-up. It is anticipated that each grant would range from \$2,500 to \$11,000 and would receive final approval by City staff prior to commencement of work. The roles and responsibilities of RTLTB and the LBCIC are outlined below:

Rebuilding Together Long Beach

- Market and promote the program in existing Long Beach mobile home communities;
- Receive and review all applications for assistance;
- Verify income eligibility;
- Verify property Titles;
- Conduct initial property inspection;
- Prepare scope of work write-up and budget;
- Prepare a project budget for each grant application;
- Submit conditionally-approved applications to LBCIC/City staff for final review and approval.

Long Beach Community Investment Company /City Staff Upon Receipt of Applications from RTLTB

- Confirm income eligibility of applicant;
- Approve scope of work write-up and budget.

Rebuilding Together Long Beach Upon LBCIC/City Staff Approval of Each Application

- Complete all work described in the approved write-up;
- Conduct final walk-through (with LBCIC/City staff upon request);
- Compile report documenting completion of all work, to include all proof of payment receipts and photographs of finished work;
- Submit draw requests to LBCIC with no more than 70% being distributed prior to completion of all work.

Long Beach Community Investment Company /City Staff Upon Approval of Each Application

- Process payment (draw) requests submitted by RTLTB.
