

FIRST AMENDMENT TO CONTRACT

THIS FIRST AMENDMENT TO CONTRACT (this "Amendment") is made and entered, in duplicate, as of March 31, 2012, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 19, 2011, by and between the FAIR HOUSING FOUNDATION, a California non-profit corporation ("Organization"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered into a Contract dated April 1, 2011 (the "Contract") whereby Organization agreed to provide programs and services toward the elimination of illegal discrimination in housing and the elimination of impediments to fair housing choices; and

WHEREAS, the parties desire to extend the term of the Contract.

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Contract, the parties agree as follows:

1. Section 2 of the Contract is hereby amended so that the term of the Contract shall expire at 11:59 p.m. on March 31, 2013, unless sooner terminated as provided in the Contract. The parties shall have one mutual extension option remaining under the Contract.

2. Except as expressly amended herein, all of the terms and conditions of the Contract are ratified and confirmed and shall remain in full force and effect.
