**RE: Strengthening Implementation in Responsible Fatherhood Programs Project,  
Agreement No. 1309-LB-01, Second Modification**

Dear Thomas Modica:

MDRC and City of Long Beach (the "Organization") entered into an agreement in August 2021 (the "Original Agreement") in order for the Organization to assist in the Strengthening the Implementation of Responsible Fatherhood Programs project ("SIRF" or the "Project") and modified the Original Agreement in April 2022 to revise the payment schedule. This letter constitutes the second modification (the "Second Modification") to the Original Agreement, as amended in order to increase the payment amount and to add an additional milestone.

With this Second Modification, the Original Agreement as amended, is modified as follows:

1. Payment Amount

This total payment amount is hereby increased by \$5,000 (five thousand dollars) from \$125,000 to \$130,000 (one hundred thirty thousand dollars). Organization will receive payment upon completion of the agreed-upon deliverables as specified in the Payment Schedule, attached hereto and incorporated herein as Exhibit A.

All other terms and conditions of the Original Agreement, as amended, remain in full force and effect.

Total payment amount: \$130,000

Payment period: Q1/21 - Q3/22

Milestone	Expected Estimated Timing	Payment Amount	Milestone Details
Approval of Learning Cycle Implementation Plan	Q1/21	\$25,000	Expect that this would be finalized at time of signing MOU.
Onboarding activities completed by learning cycle manager	early in Q2/21	\$25,000	Learning cycle manager is appointed (or hired) and completes organizational onboarding activities plus SIRF training.
Learning cycle documentation (two payments)	Between Q2/21 – March 22, 2022	\$25,000 x 2	By the end of each learning cycle, the program will produce and submit a reflection form. Within 3 days of submitting each report, staff will hold a meeting with the SIRF team.  Payments will be made upon submission of these files at the completion of the first and second learning cycle.
Final Learning Community Meeting	Q3/22	\$25,000	Participate in final learning community / site meeting
Written summative reflection	Q3/22	\$5,000	Submit final written reflection piece, providing cross-cycle feedback on learning cycle implementation and SIRF participation and support.
