THIS SECOND AMENDMENT TO AGREEMENT NO. 35398 is made and entered, in duplicate, as of August 16, 2021 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 10, 2021, by and between STANTEC CONSULTING SERVICES INC., a New York corporation ("Consultant"), with a place of business at 370 Interlocken Blvd., Suite 300, Broomfield, Colorado 80021, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35398 (the "Agreement") whereby Consultant agreed to provide as-needed, on-call consulting services for street design projects; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to reduce the amount by \$500,000 for a total not to exceed amount of \$500,000; and

WHEREAS, the Parties desire to add \$1,000,000 for a total not to exceed amount of \$1,500,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, in an amount not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000), at the rates or charges shown in Exhibit "B"."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 35398 are ratified and confirmed and shall remain in full force and effect.
