ORDINANCE NO.

AN ORDINANCE OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AMENDING THE LONG BEACH
MUNICIPAL CODE BY AMENDING SECTION 10.32.110
RELATING TO PREFERENTIAL PARKING DISTRICT R

WHEREAS, after a duly-noticed public hearing, the City Council determines
and finds that more than sixty-six and two-thirds percent (66 $\frac{2}{3}$ %) of the occupants of all
residential units on the Palo Verde service road between Atherton Street service road and
Marita Street, and on Tevis Avenue between the Atherton Street service road and
Dayman Street, have indicated a positive desire for preferential parking privileges; and

WHEREAS both locations have existing limited-time parking; and

WHEREAS, said areas are zoned as residential; and

WHEREAS, the City Traffic Engineer has notified each of the properties
within the proposed expanded area of District "R"; and

WHEREAS, the area is a logical expansion of existing Preferential Parking
District "R"; and

WHEREAS, the area meets the requirements for a preferential parking
district pursuant to Long Beach Municipal Code Section 10.32.020;

NOW, THEREFORE, the City Council of the City of Long Beach does
hereby ordain as follows:

Section 1. District "R" of Section 10.32.110 of the Long Beach Municipal
Code is hereby amended to read as follows:

10.32.110 Areas Designated

Dayman Street; both sides of Fanwood Avenue between Atherton Street and Marita Street; north side of Dayman Street from Conquista Avenue to a point two hundred sixty two feet (262') west of Carfax Avenue; south side of Dayman Street between Conquista Avenue and Tevis Avenue; both sides of the Palo Verde Avenue service road between the Atherton Street service road and Marita Street; both sides of Tevis Avenue between the Atherton Street service road and Dayman Street;

Sec. 2. The City Clerk shall certify to the passage of this ordinance by the City Council of the City of Long Beach and cause the same to be posted in three conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first day after it is approved by the Mayor.
