3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH AUTHORIZING THE CITY  
5 MANAGER TO EXECUTE A CONTRACT AND ANY  
6 AMENDMENTS THERETO WITH DOOLEY ENTERPRISES,  
7 INC. WITHOUT ADVERTISING FOR BIDS FOR  
8 FURNISHING AND DELIVERING WINCHESTER  
9 AMMUNITION FOR A PERIOD OF TWO YEARS IN AN  
10 ANNUAL AMOUNT NOT TO EXCEED \$400,000

12 WHEREAS, the City requires ammunition manufactured by Winchester for  
13 training and shooting qualification requirements for LBPD armed personnel; and

14 WHEREAS, LBPD has standardized its training rounds and premium duty  
15 rounds with Winchester factory-loaded ammunitions since 2004; and

16 WHEREAS, Dooley Enterprises, Inc. is the sole authorized distributor in  
17 California that supplies Winchester ammunition; and

18 WHEREAS, as a result, no useful purpose would be served by advertising  
19 for bids for furnishing and delivering this type of ammunition and to do so would constitute  
20 an idle and useless act and an unnecessary expenditure of public funds because Dooley  
21 Enterprises, Inc. is the only corporation, firm or individual that could or would bid for the  
22 furnishing of Winchester factory-loaded ammunition to the City;

23 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
24 follows:

25 Section 1. The above recitals are true and correct and are incorporated  
26 herein.

Section 2. The City Manager is hereby authorized to enter a contract and any amendments thereto with Dooley Enterprises, Inc. for furnishing and delivering Winchester ammunition in an annual amount not to exceed Four Hundred Thousand Dollars (\$400,000), for a period of two years, with the option to renew for three additional one-year periods.

Section 3. This resolution shall take effect immediately upon its adoption by the City Council, and the City Clerk shall certify the vote adopting this resolution.
