3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29142 is made and
4 entered, in duplicate, as of February 2, 2006 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting held
6 on June 1, 2004, by and between PUBLIC RESOURCES MANAGEMENT LLC, a
7 California limited liability company, whose business address is 1380 Leadhill Boulevard
8 #106, Roseville, California 95661 ("Consultant"), and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, the parties entered Agreement No. 29142 whereby
11 Consultant agreed to provide services in connection with a City-wide fee study; and

12 WHEREAS, the parties desire to extend the term of the Agreement;

13 NOW, THEREFORE, in consideration of the mutual terms and conditions
14 in Agreement No. 29142 and herein, the parties agree as follows:

15 1. Section 2 of Agreement No. 29142 is hereby amended in its entirety to
16 read as follows:

17 "2. TERM. The term of this Agreement shall commence at midnight on
18 June 1, 2004, and shall terminate at 11:59 p.m. on May 31, 2006, unless sooner
19 terminated as provided in this Agreement, or unless the services to be performed
20 hereunder or the Project is completed sooner."

21 2. Except as expressly amended in this First Amendment, all terms and
22 conditions in Agreement No. 29142 are ratified and confirmed and shall remain in full
23 force and effect.
