	striping plans, for the negotiated unit cost of \$2.32 per square foot (6,250/SF @
	\$2.32/SF),

as directed by the Project Manager,

2. Provide all labor, materials and equipment for additional potholing of existing asphalt street section, as directed by the City to find the thickness of the existing asphalt and to determine driving ability on the roadway after cold milling.

as directed by the Project Manager,

for the estimated cost of.....\$ 637.92

3. Add Alternative Bid Line Item No. 78 "Concrete Rémoval for Tree Well" at the unit bid cost of \$150.00 per cubic yard, for the estimated cubic yard of 23.67 (23.67/CY @ \$150.00/CY),

as directed by the Project Manager,

for the estimated cost of.....\$ 3,550.50

4. Provide all labor, materials and equipment to place Safety Step Down truncated dome in lieu of Cast in Place truncated domes, at a negotiated unit cost of \$56.91 per square foot (96/SF @ \$56.91/SF),

as directed by the Project Manager,

for the estimated cost of......\$ 5,463.36
