FIRST AMENDMENT TO AGREEMENT NO. 36316

THIS FIRST AMENDMENT TO AGREEMENT NO. 36316 is made and entered, as of March 7, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on May 24, 2022, by and between KEESAL, YOUNG & LOGAN ("Special Counsel") and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Special Counsel (the "Parties") entered into Agreement No. 36316 whereby Special Council agreed to provide legal services related to a contract for construction of a multi-purpose patrol vessel with Safe Harbor New England Boatworks; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW THEREFORE, in consideration of the mutual terms, covenants and conditions contained herein, the Parties agree as follows:

1. Section 8 of Agreement No. 36316 is hereby amended to read as follows:

"8. TERM. The term of this Agreement shall begin at 12:01 a.m. on April 1, 2022, and shall terminate at 11:59 p.m. on March 31, 2024, or shall end on fifteen (15) days' prior notice from the City to Special Counsel. The parties have no further options to extend the term."

2. Except as expressly amended herein, all terms and conditions in Agreement No. 35979 are ratified and confirmed and shall remain in full force and effect.




