RESOLUTION NO. RES-18-0035

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE TECHNOLOGY PROFESSIONAL SERVICES THROUGH THE AGREEMENT BETWEEN COUNTY OF SANTA CLARA AND GARTNER, INC.

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase Technology Professional Services ("Technology Services"); and

WHEREAS, the COUNTY OF SANTA CLARA has an agreement with GARTNER, INC. for the purchase of these Technology Services, Agreement No. 70754 ("Agreement"); and

WHEREAS, the City's participation in the Agreement will facilitate acquisition of these Technology Services as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Agreement considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. The City Manager or designee of the City is hereby authorized

1 to enter an agreement with GARTNER, INC. to purchase Technology Services of
2 substantially the same type and kind purchased by the COUNTY OF SANTA CLARA
3 pursuant to the Agreement except as modified by mutual agreement of the City and
4 GARTNER, INC., and the purchase by the City shall be on the same terms and
5 conditions afforded to the COUNTY OF SANTA CLARA in an amount not to exceed
6 Three Hundred Thousand Dollars (\$300,000) including tax and shipping, for a period
7 ending March 12, 2019.

8 Section 3. This resolution shall take effect immediately upon its adoption
9 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
