WHEREAS, City granted Permittee permission to use and occupy portions of the docks, the slips and end ties in the Rainbow Harbor; and

WHEREAS, the parties desire to amend this permit by extending the term;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Permit No. 29814, the parties agree as follows:

- 1. Section 3 of Permit No. 29814 is hereby amended in its entirety to read as follows:
- "1. The first extended term of this Permit shall commence on January 1, 2009 and shall terminate on December 31, 2011. This Permit may be extended for one (1) additional period of (3) three years at the sole discretion of the City Manager. Notwithstanding the foregoing, either party may terminate this Permit at any time for any or no reason upon sixty (60) days' written notice to the other party. Upon termination of this Permit (whether by lapse of time or otherwise), Permittee shall quit and surrender possession of the Permit Area and remove its personal property therefrom.
- Except as expressly stated herein, all of the terms, covenants, and conditions of Permit No. 29814 are ratified and confirmed and shall remain in full force and effect.
