FIRST AMENDMENT TO AGREEMENT NO. 34501

THIS FIRST AMENDMENT TO AGREEMENT NO. 34501 is made and entered into, in duplicate, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 19, 2016, by and between BEACH OIL MINERALS PARTNERS, LLC (BOMP)("Applicant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 34501 ("Agreement") whereby Applicant agreed to reimburse City for costs incurred by City for project management for entitlements for wetlands restoration of a portion of property at 6433 East Second Street and relocation of oil facilities to 6701 East Pacific Coast Highway set forth in Exhibit "A" of the Agreement; and

WHEREAS, the parties desire to extend the term;

NOW, THEREFORE, in consideration of the terms and conditions in the Agreement and in this First Amendment, the parties agree as follows:

- 1. Section 10 of Agreement No. 34501 is hereby amended to read as follows:
 - "10. This Agreement shall commence effective as of January 1, 2016 and shall terminate on April 1, 2018 (the "Termination Date") unless sooner terminated as provided below. However, the Parties may mutually agree in writing to extend the term of this Agreement by negotiating such extension at least sixty (60) calendar days prior to the Termination Date. Notwithstanding anything to the contrary contained in this Agreement, in no event shall the term of this Agreement extend beyond the end of the month in which an extension is completed and entered into by the Parties.
- Except as expressly amended in this First Amendment, all terms and conditions in Agreement No. 34501 are ratified and confirmed and shall remain in full
