THIS AMENDMENT NUMBER TWO ("Amendment Number Two") to Agreement Number 2020CBH105 ("Agreement") is made and entered into by and between the Los Angeles Homeless Service Authority ("LAHSA"), a joint powers authority of the City and County of Los Angeles, and City of Long Beach ("Contractor"), a 501(c)(3) organization incorporated under the laws of the State of California, the "Parties".

NOW, THEREFORE, in consideration of the mutual covenants herein set forth and the mutual benefits to be derived therefrom, the Parties agree as follows:

**AMENDMENT**

Effective on the date of LAHSA's Executive Director's signature, the Agreement is amended.

1. **RECITALS** is hereby amended as follows:

Add the following:

"WHEREAS, on September 2, 2020, LAHSA and Contractor executed Contract Number 2020CBH105, as subsequently amended;

WHEREAS, LAHSA has implemented the Enterprise Grants Management System (EGMS) to manage and administer funding to subrecipients, including to Contractor;

WHEREAS, LAHSA and Contractor executed an agreement under EGMS ID Numbers **AD-BH-BH-028-01** and **AD-CH-CH-003-01** to allow for the terms of the Agreement to be administered through EGMS;

WHEREAS, LAHSA and Contractor now desire to amend the Agreement for the purposes of: (a) terminating Contract Number 2020CBH105, as amended; (b) administering the terms of the Agreement under EGMS ID Numbers **AD-BH-BH-028-01** and **AD-CH-CH-003-01**; (c) making such other changes as are required in connection with all of the foregoing, as detailed elsewhere in this Amendment Number Two;

WHEREAS, Section 70., **CHANGES AND AMENDMENTS OF TERMS**, provides for said amendments;"

2. The following provision is added as section 109., **TERMINATION OF AGREEMENT**, to the Agreement:

LAHSA and Contractor agree to terminate Contract Number 2020CBH105, as amended.

3. The following provision is added as section 110., **ENTERPRISE GRANTS MANAGEMENT SYSTEM**, to the Agreement:

LAHSA and Contractor agree to continue the Program which is the subject of Contract Number 2020CBH105 under EGMS ID Numbers **AD-BH-BH-028-01** and **AD-CH-CH-003-01**, which shall be administered through the EGMS.


