

1 SECOND AMENDMENT TO AGREEMENT NO. 34499

3 THIS SECOND AMENDMENT TO AGREEMENT NO. 34499 is made and  
4 entered, in duplicate, as of March 27, 2019, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting on  
6 January 10, 2017, by and between A & A TOWING, INC., a California corporation  
7 ("Contractor"), with a place of business at 3204 CHERRY AVE., LONG BEACH, CA  
8 90807, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be  
10 performed in connection with As Needed Towing Services ("Project"); and

11 WHEREAS, the parties entered Agreement No. 34499 whereby Contractor  
12 agreed to provide these services; and

13 WHEREAS, the parties desire to extend the term and add the annual  
14 amount of Ninety Thousand Dollars (\$90,000) for a total not to exceed contract amount of  
15 Three Hundred Twenty Thousand Dollars (\$320,000);

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
17 conditions herein contained, the parties agree as follows:

18 1. Section 1.A. of Agreement No. 34499 is hereby amended to read as  
19 follows:

20 "A. Contractor shall furnish specialized services more particularly  
21 described in Exhibit "A", attached to this Agreement and incorporated by this  
22 reference, in accordance with the standards of the profession and the terms and  
23 conditions stated herein, and City shall pay for these services in the manner  
24 described below, in the amounts not to exceed Ninety Thousand Dollars (\$90,000)  
25 annually for the period of May 1, 2016 through April 30, 2018, Fifty Thousand  
26 Dollars (\$50,000) annually for the period of May 1, 2018 through April 30, 2019,  
27 and Ninety Thousand Dollars (\$90,000) annually for the period of May 1, 2019  
28 through April 30, 2020, at the rates or charges shown in Exhibit "B".

1                   2.     Section 2. Of Agreement No. 34499 is hereby amended to read as  
2 follows:

3                   “2.     TERM.       The term of this Agreement shall commence at  
4 midnight on May 1, 2016, and shall terminate at 11:59 p.m. on April 30, 2020,  
5 unless sooner terminated as provided in this Agreement, or unless the services or  
6 the Project is completed sooner.”

7                   3.     Section 31. is hereby added to Agreement No. 34499 to read as  
8 follows:

9                   “A.     VERIFICATION OF TOW OPERATOR PERMITS.  
10 Contractor shall furnish a list of current tow operators with corresponding permit  
11 numbers to the Superintendent of Towing & Lien Sales on an annual basis, and  
12 upon request, for the purpose of verifying the status of tow operator permits  
13 required by the Long Beach Municipal Code.”

14                  4.     Except as expressly modified herein, all of the terms and conditions  
15 contained in Agreement No. 34499 are ratified and confirmed and shall remain in full  
16 force and effect.
