FOURTH AMENDMENT TO AGREEMENT NUMBER C-124773 OF CITY OF LOS ANGELES CONTRACT

BETWEEN

THE CITY OF LOS ANGELES

AND

THE CITY OF LONG BEACH, ACTING BY AND THROUGH ITS POLICE DEPARTMENT

THIS FOURTH AMENDMENT to Agreement Number C-124773 ("Fourth Amendment") is made and entered into by and between the City of Los Angeles, a municipal corporation (the "City"), and the City of Long Beach, a municipal corporation, acting by and through its Police Department, a political subdivision of the State of California (the "Subgrantee" or "Subrecipient").

WITNESSETH

WHEREAS, the City and Subrecipient entered into that certain City of Los Angeles Contract Number C-124773 (the "Agreement") related to the Securing the Cities Program Grant provided by the Grantor (as such term is defined in the Agreement) to the City (the "Grant"), whereby the City agreed to reimburse certain expenses incurred by the Subrecipient as a participating agency in the STC Program (as such term is defined in the Agreement) from the Grant allocations for Fiscal Year 12 ("FY 12") and Fiscal Year 13 ("FY 13"), such Agreement having a term of January 1, 2013 to July 14, 2015, with a maximum reimbursement amount from FY 12 and FY 13 Grant funds to Subrecipient in the amount of Two Hundred Sixty-Four Thousand Six Hundred Dollars (\$264,600.00), and the execution of said Agreement having been authorized by the Los Angeles City Council (C.F.# 13-1301, dated 11/05/2013); and

WHEREAS, on or about May 11, 2016, the City and the Subrecipient entered into that certain First Amendment to the Agreement ("First Amendment") which increased Subrecipient's allocation of Grant funds to Four Hundred Thousand Four Hundred Dollars (\$400,400.00) and extended the Agreement performance period to July 14, 2016, to reflect Subrecipient's allocation under the Grant ("FY 14 & 15 Grant Allocation"), such FY 14 & 15 Grant Allocation and First Amendment having been authorized by the Los Angeles City Council (C.F.# 13-1301-S1, dated 01/07/2015, and 01/19/2016); and

WHEREAS, on or about October 20, 2017, the City and the Subrecipient entered into that certain Second Amendment to the Agreement ("Second Amendment") which increased Subrecipient's allocation of Grant funds to Four Hundred Eighteen Thousand Six Hundred Sixty-Three Dollars (\$418,663.00) and extended the Agreement performance period to October 14, 2017, to reflect Subrecipient's allocation under the Grant ("FY 16 Grant Allocation"), such FY 16 Grant Allocation and Second Amendment having been authorized by the Los Angeles City Council (C.F.# 13-1301-S2, dated 01/07/2015, and 04/05/2017); and

WHEREAS, on or about September 13, 2018, the City and Subrecipient entered into that certain Third Amendment to the Agreement ("Third Amendment") which extended the Agreement performance to October 18, 2019, (FY 17 & 18 Grant Extensions), pursuant to authorization by the Los Angeles City Council (C.F. #13-1301-S2, dated 05/01/2018 and 04/05/2019) and as authorized by Section 14.8 of the Los Angeles Administrative Code ("Section 14.8"), and

WHEREAS, on or about December 12, 2018, the Grantor approved the STC Program FY 12-16 Budget modification ("STC Grant Budget") such that Subrecipient's allocation of Grant funds was increased by the amount of Three Thousand One Hundred Ninety-Four Dollars and

Eighty-Four Cents (\$3,194.84) to Four Hundred Twenty One Thousand Eight Hundred Fifty-Seven Dollars and Eighty-Four Cents (\$421,857.84), such modification having been authorized by the Los Angeles City Council (C.F.# 13-1301-S2, dated April 5, 2019); and

WHEREAS, on or about June 5, 2019, the Grantor extended the Grant performance period for all allocations under the Grant to October 14, 2020, (the "FY 19 Grant Extension"), such FY 19 Grant Extension having been authorized by the Los Angeles City Council (C.F. #13-1301-S2; dated 7/1/20); and

WHEREAS, on or about 9/19/19, the City approved a modification to the above-referenced STC Grant Budget, such that Subrecipient's allocation of Grant funds was decreased by the amount of Two Hundred Twenty-Two Thousand Four Hundred Fifteen Dollars and Thirty-Four Cents (\$222,415.34), to One Hundred Ninety-Nine Thousand Four Hundred Forty-Two Dollars and Fifty Cents (\$199,442.50), such modification having been authorized by the Los Angeles City Council (C.F.# 13-1301-S2, dated 7/1/20); and

WHEREAS, Section 502 of the Agreement provides for amendments to the Agreement; and

WHEREAS, the City, through its Mayor's Office of Public Safety ("Mayor's Office"), which has been designated by the City to administer the Agreement and the projects contemplated therein, and Subrecipient each desires to enter into this Fourth Amendment for the purpose of amending the Agreement to: (a) adjust Subrecipient's reimbursement amount of Grant funds under the Agreement to reflect the STC Grant Budget modification, (b) extend the term of the Agreement to reflect the FY 19 Grant Extension, and (c) make such other changes as are required in connection with the foregoing, all as detailed elsewhere in this Fourth Amendment and as authorized by the Los Angeles City Council (C.F. 13-1301-S2, dated 7/1/20) and as authorized by Section 14.8; and

WHEREAS, this Fourth Amendment is necessary and proper to continue and/or complete certain activities authorized under the Agreement.

NOW, THEREFORE, the City and Subrecipient hereby covenant and agree that the Agreement, as previously amended, be further amended, effective January 1, 2013, as follows:

1. Section 201 of the Agreement entitled "Performance Period" is hereby amended in its entirety to read as stated within the quotation marks in the following paragraph:

"The term of this Agreement shall be from January 1, 2013 and end October 14, 2020 (the "Term"). Subrecipient shall cooperate with the City and Grantor in completing any necessary close out activities in connection with the Grant."

2. Paragraph A of Section 301 of the Agreement entitled "Reimbursement of Grant Funds and Method of Payment" is hereby amended in its entirety to read as stated within the quotation marks in the following paragraph:


"The City of Los Angeles shall reimburse Subrecipient from Grant funds for personnel expenses incurred by Subrecipient in connection with STC Program training and exercise activities as described in Section 202 above. Such reimbursement shall, in no event, exceed to One Hundred Ninety-Nine Thousand Four Hundred Forty-Two Dollars and Fifty Cents (\$199,442.50), which represents the maximum reimbursement amount

allocated to Subrecipient and approved by the Mayor's Office and the Grantor for the STC Grant Budget.

Such amendment amends Subrecipient's maximum reimbursement amount from Grant funds as set forth in the STC Grant Budget.

3. Except as herein amended or modified, all terms and conditions of the Agreement, as previously amended, shall remain unchanged and in full force and effect by way of this Fourth Amendment.
4. This Fourth Amendment may be executed in one or more counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument. This Fourth Amendment includes four pages which constitute the entire understanding and agreement of the parties with respect to the matters set forth herein.
