SECOND AMENDMENT TO AGREEMENT NO. 28298

- "2. <u>TERM</u>. The initial term of this Agreement shall commence at midnight on March 25, 2003, and shall terminate at 11:59 p.m. on March 24, 2006. The extended term of this Agreement shall commence at midnight on March 25, 2006 and, unless sooner terminated as provided in this Agreement, or unless the services to be performed hereunder or the Project is completed sooner, shall terminate at 11:59 p.m. on March 24, 2007."
