<u>AGREEMENT</u>

THIS AGREEMENT is made and entered, in duplicate, as of May 24, 2017, for reference purposes only, pursuant to Resolution No. RES-17-0052, adopted by the City Council of the City of Long Beach at its meeting on May 23, 2017, by and between ZONAR SYSTEMS, INC, a Washington corporation ("Contractor"), with a place of business at 18200 Cascade Ave. S #200, Seattle, WA 98188, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City currently has 583 active units in the City's fleet in need of Zonar electronic vehicle inspection and tracking components as well as monthly monitoring services; and

WHEREAS, City did by Resolution No. RES-17-0052 determine that the City's need to purchase Zonar electronic vehicle inspection and tracking components including monitoring services could only be met by Contractor and, by reason of the foregoing, no useful purpose would be served by advertising for bids to purchase Zonar electronic vehicle inspection and tracking components including monitoring services, and to do so would constitute an idle and useless act and an unnecessary expenditure of public funds; and

WHEREAS, City has selected Contractor in accordance with City's administrative procedures and City has determined that Contractor and its employees are qualified, licensed, if so required, and experienced in performing these specialized services; and

WHEREAS, City desires to have Contractor perform these specialized services, and Contractor is willing and able to do so on the terms and conditions in this Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in this Agreement, the parties agree as follows:

- 1. Contractor shall sell, furnish and deliver to City Zonar electronic vehicle inspection and tracking components including monitoring services as authorized by Resolution No. RES-17-0052 and as described in Exhibit "A" attached to this Contract and incorporated herein by this reference.
- 2. City shall pay Contractor in due course of payments, following receipt of an invoice from Contractor and upon acceptance from City, for these Zonar electronic vehicle inspection and tracking components including monitoring services at the prices shown in Exhibit "A", a sum not to exceed Two Hundred Fifty Thousand Dollars (\$250,000) annually, including tax.
- 3. The term of this Contract shall commence at midnight on July 22, 2017, and shall terminate on July 21, 2019 unless sooner terminated as provided herein. The City has the option to extend the contract for two (2) additional periods of one (1) year each at the discretion of the City Manager, and may terminate this Contract by giving thirty (30) days prior notice of termination to Contractor.
- 4. Neither this Contract nor any of the moneys that may become due Contractor hereunder may be assigned without the prior written consent of City; however, Contractor may assign this Contract to any current or future affiliate in connection with a merger or sale of all or substantially all of Contractor's assets used in performing its obligations under this Contract without prior written consent.
- 5. Any notices required hereunder or desired to be given by either party shall be in writing and personally delivered or deposited in the U.S. Postal Service, first class postage prepaid, addressed to Contractor at the address stated herein, and to City at 333 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager. Notice shall be deemed given on the date personal delivery is made or on the date of deposit in the mail, whichever first occurs.
- 6. City shall have the benefit of any warranty from the manufacturer on the products supplied and Contractor warrants that the products are in good working order and free from defect at the time of delivery.
