

1 SIXTH AMENDMENT TO AGREEMENT NO. 33801

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 33801 is made and
4 entered, in duplicate, as of August 31, 2018, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on March
6 24, 2015, by and between CALIFA GROUP, a California corporation ("Califa"), with a place
7 of business at 32 West 25th Avenue, Suite 201, San Mateo, California 94403, and the CITY
8 OF LONG BEACH, a municipal corporation ("City") acting through its Library Services
9 Department ("Library"), whose address is 101 Pacific Avenue, Long Beach, California
10 90822.

11 WHEREAS, City desires to purchase high-speed data communication
12 services for the Department of Library Services; and

13 WHEREAS, City and Califa (the "Parties") entered into Agreement No. 33801
14 (the "Agreement") whereby Califa agreed to provide such services; and

15 WHEREAS, the Parties entered into a First Amendment to the Agreement to
16 purchase high-speed data communications network equipment and increase the
17 Agreement amount by \$134,000 for the equipment; and

18 WHEREAS, the Parties entered into a Second Amendment to the Agreement
19 to attach a revised Appendix I; and

20 WHEREAS, the Parties entered into a Third Amendment to the Agreement
21 to attach a revised Appendix I to remove the costs of the circuit to the North Branch Library;
22 and

23 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
24 to attach a revised Appendix I, effective March 1, 2017, and to reflect a reduction in costs
25 for all circuits; and

26 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to
27 attach a revised Appendix I, effective February 2018; and

28 WHEREAS, the Parties desire to extend the term one (1) additional one-year

2 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
3 conditions herein contained, the Parties agree as follows:

4 1. Section 3 (a) of the Agreement is hereby amended as follows:

5 "(a) TERM OF THIS AGREEMENT. This Agreement shall be in effect from
6 July 1, 2015 through June 30, 2019. This Agreement may extended for one (1) additional
7 one-year period upon at least sixty (60) days' notice to Califa prior to termination of the
8 then current term. City understands that failure to notify Califa of renewal by the deadline
9 will result in circuit termination, in which case there is no guarantee that circuit may be
10 reinstalled at the same costs as included in Appendix I."

11 2. Except as expressly amended in this Amendment, all terms and
12 conditions in Agreement No. 33801 are ratified and confirmed and shall remain in full
13 force and effect.






