WHEREAS, the Parties entered into a First Amendment to the Agreement to extend the term to September 30, 2020 and add \$500,000 to the Agreement for a total not to exceed amount of \$1,100,000; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on October 1, 2017, and shall terminate at 11:59 p.m. on September 30, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."
- 2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34816 are ratified and confirmed and shall remain in full force and effect.
