The Board of Directors of Friends of Belmont Shore is pleased to support the application of 5283, LLC for a Conditional Use Permit in connection with its establishment of "Louie's on 2nd" at 5283 East 2nd Street in Belmont Shore. Our mission is to enrich the quality of life in Belmont Shore and surrounding areas through a platform of interests, concerns and advocacy. As part of that mission, Friends of Belmont Shore strives to support and promote the local 2nd Street businesses that make our community so vibrant and unique.

Louie's on 2nd has deep historical ties to Long Beach and the very location on 2nd Street where it plans to operate. In addition, the owners are cognizant of the issues associated with alcohol consumption at other bars in Belmont Shore (including the previous tenant at 5283 East 2nd Street) and are taking steps to avoid those problems. For these reasons, we support 5283, LLC's application for a Conditional Use Permit to operate Louie's on 2nd with a Type 47 on-premises liquor license and look forward to welcoming Matt, Chris and Angelo Tavlarides back to the Shore.






