RESOLUTION NO. RES-12-0116

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AUTHORIZING THE CITY MANAGER TO PURCHASE PARTS AND SERVICE FOR BMW MOTORCYCLES THROUGH THE REQUEST FOR QUOTATION BETWEEN THE CITY OF SANTA MONICA AND R.C.A. INVESTMENTS, INC. DBA LONG BEACH BMW MOTORCYCLES

WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802, permits the City to purchase services, supplies, materials, equipment and labor with other government agencies by purchasing under their contracts on a voluntary and selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase parts and service for BMW police certified motorcycles; and

WHEREAS, the City of Santa Monica has a Request for Quotation for the purchase of BMW motorcycle parts and service, Quotation No. 37842-OG ("Santa Monica RFQ"); and

WHEREAS, the City's participation in the Santa Monica RFQ will facilitate acquisition of these BMW motorcycle parts and service as well as provide considerable cost benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the Santa Monica RFQ considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated herein by this reference.

1 Section 2. The City Manager of the City is hereby authorized to enter an
2 agreement with R.C.A. Investments, Inc. dba Long Beach BMW Motorcycles to purchase
3 BMW motorcycle parts and service of substantially the same type and kind purchased by
4 the City of Santa Monica pursuant to the Santa Monica RFQ except as modified by
5 mutual agreement of the City and R.C.A. Investments, Inc. dba Long Beach BMW
6 Motorcycles, and the purchase by the City shall be on the same terms and conditions
7 afforded to the City of Santa Monica in an amount not to exceed \$125,000, including tax
8 and shipping, for a period of one year, with the option of renewing for one additional one-
9 year period, extending until the warranty on the BMW motorcycle parts and service
10 expires.

11 Section 3. This resolution shall take effect immediately upon its adoption
12 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
