WHEREAS, City and Contractor (the "Parties") entered into Agreement No. 34328 (the "Agreement") whereby Contractor agreed to provide graffiti removal services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to attach a revised rate sheet and extend the term to June 31, 2020; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add the authorized annual amount;
