RECOMMENDATION:

Receive the supporting documentation into the record, conclude the hearing and grant the permit, with or without conditions, grant a one year short-term permit, with or without conditions, or deny the permit on the application of Warne Let LLC, DBA Hamburger Mary's, 740 E. Broadway, for Entertainment With Dancing by Patrons at an existing Restaurant. (District 2)

DISCUSSION

The Long Beach Municipal Code (LBMC) requires an application be filed and a hearing be held before the City Council whenever this type of activity is requested and before an entertainment permit is granted or denied.

The LBMC also requires that the City Council make a determination that the application is complete and truthful; the applicant, the person interested in the ownership and operation of the entity, and the officers and trustees of the entity are law-abiding persons who will operate and conduct the business activity in a lawful manner; and, that the public peace, welfare, and safety will not be impaired. If this is so, the application shall be approved, a short-term permit shall be approved, or the application shall be denied.

Attached for your review is the application from Warne Lo LLC, DBA Hamburger Mary's. Also attached are reports from various departments and a summary of those reports, as well as the license history of the establishment.

City departments have conducted their investigation in accordance with the LBMC. The following summarizes their findings:

- The Police Department recommends that the permit for entertainment with dancing by patrons be approved subject to conditions.
- The Fire Department recommends that the permit for entertainment with dancing by patrons be approved.

- The Health and Human Services Department finds that the building/location meets department requirements for the proposed use with the condition that the establishment remain in compliance with the Long Beach Noise Ordinance (LBMC Chapter 8.80).
- The Long Beach Development Services Department recommends that the permit for entertainment with dancing by patrons be approved.

In the event that any of the recommended conditions attached to any permit or licenses are in conflict, the permittee shall adhere to the strictest of the applicable conditions. This location has been licensed as a restaurant with alcohol since October 2000.

This matter was reviewed by Deputy City Attorney Cristyl Meyers on September 24, 2008.

TIMING CONSIDERATIONS

The hearing date of October 21, 2008, has been posted on the business location, with the applicant and property owners within 300 feet notified by mail.

FISCAL IMPACT

The following fees were collected with the application: Building Review \$20 and Zoning Review \$14 (Long Beach Development Services Department), Police Investigation \$1,000 (Police Department), Temporary Permit \$300, Labels \$90 (Financial Management Department), and Health/Noise Control \$94 (Health and Human Services Department).

The following fees will be collected if the application is approved: Business License \$325.85 and Regulatory \$825 (Financial Management Department).

In response to your request for a recommendation regarding the above named permit application for Entertainment with Dancing, the Police Department recommends approval, subject to the following eighteen (18) conditions of operation:

Hamburger Mary's is a restaurant/nightclub located at the southwest corner of Broadway and Alamitos Avenue. The business is owned and operated by Dale Warner and Ruben Lopez, who also own Hamburger Mary's in West Hollywood. The restaurant serves domestic food and is open for lunch and dinner. The permittee will provide entertainment activities during and after dinner. There has been no disciplinary action taken against the West Hollywood Hamburger Mary's. Since opening, there have been no adverse incidents at the Long Beach location.

CONDITIONS OF OPERATION

- The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.
- 2) Unless separately applied for, reviewed and approved, no adult entertainment, as defined by section 5.72.115(B) LBMC shall be conducted on the permitted premises.
- 3) The permittee shall not allow any person (employee, independent contractor, dancer or customer) to perform or conduct any activity that emphasizes any of the below listed sexual activities which are common during a "lap dance."
 - A. Actual or simulated, sexual intercourse, anal intercourse, oral or anal copulation.
 - B. Direct physical stimulation, fondling or touching of clothed or unclothed human genitals, pubic region, buttocks or female breasts.

- 4) Hamburger Mary's shall not advertise, procure, nor allow any person, performance, show, promotion, or any other event or entertainment that exposes or promotes, encourages, or allows the exposure of the male or female genitals, cleft of the buttocks, the areola or any portion of the female breast below the areola, while at or inside the business.
- Patrons under twenty-one (21) years of age shall not be permitted to enter nor to remain on the premises after the restaurant (food services) portion of the establishment has closed. Private functions not open to the public are exempt from this condition.
- Noise emanating from the permittee's premises shall not be audible 50 feet or more from the exterior of the premises. The permittee shall be responsible for determining how to best meet this requirement, either by keeping doors and windows shut, limiting hours of entertainment or by offering non-amplified entertainment.
- 7) The permittee shall not allow employees to discard trash or beer bottles into the outside dumpster between the hours of 10 p.m. and 7 a.m.
- During any entertainment activity listed on page #7 of the application, the permittee shall be responsible for maintaining an adequate security staff to supervise patrons inside the establishment and the parking lot. For crowds up to fifty (50) people, the permittee shall provide a minimum of one (1) security guard. For crowds over (50) fifty people, the permittee shall provide a minimum of one (1) additional security guard per fifty (50) people. Security guards must be identifiable as "Hamburger Mary's employees." Should the permittee's operations give rise to a substantial increase in complaints/calls for service, or trash left in the parking lot, the permittee shall increase staff, or employee uniformed licensed security guards, as directed by the Chief of Police.
- 9) The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside any of the entrance/exit doors and the parking lot, at all times open for business. This should be done by use of security guards and/or signage indicating, words to the effect of, "Please respect our neighbors."
- 10) At the conclusion of each event, the permittee shall take reasonable measures to ensure that exiting patrons walk directly to their vehicles, and not loiter in the parking lot or the immediate area.
- 11) The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incident or nuisance arising out of or in connection with the permittee's operations.

- 12) Current occupancy loads shall be posted at all times, and the permittee shall have an effective system to keep count of the number of occupants present at any given time and provide that information to public safety personnel upon request. (LBMC section 18.48.320)
- 13) This Entertainment Permit is accessory to the primary business, which is a restaurant. In the event the primary business ceases operations on a permanent basis, meaning meals are no longer offered at the location period, the entertainment permit becomes null and void.
- 14) All independent contractors, including dancers and promoters, must have or obtain a City of Long Beach Business License prior to conducting entertainment activities governed by this permit. The permittee shall be responsible for all entertainment activities at the location, including those conducted by promoters, independent contractors or dancers.
- 15) The permittee must provide all promoters, independent contractors, and dancers, hired to conduct entertainment activities with a copy of the approved permit, which shall include a copy of the approved conditions of operation.
- 16) Hamburger Mary's, its promoters, or agents, shall not distribute any advertising matter in or upon any public property, or in or on any vehicle in any such place in the City. Distribution of any advertising matter upon private property shall adhere to the following guidelines: By placing the same matter in a receptacle, clip, or other device designed or intended to receive advertising matter. The permittee shall keep all promoter contracts, including names, addresses and phone numbers, on file at all times, and must be available for inspection at anytime.
- 17) The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances and stated conditions. In the event of a conflict with the requirements of this permit, the more stringent regulation shall apply.
- The permittee, shall, within ninety (90) days of an approved entertainment permit, submit proof of attending the LEAD program offered by the Department of Alcoholic Beverage Control. In the event that the LEAD program class is not offered within this ninety day period, the permittee shall attend the next available class. Proof of completion shall be submitted to the Long Beach Police Department Vice Investigations Section.

The Community Design and Development Division of Department of Development Services has the following comments:

A review of the permit history for 740 E. Broadway indicates that previous permits for entertainment with dancing have been approved at the subject site. The approvals began with an application received in February 2002 wherein the request was approved subject to the conditions of approval of a Conditional Use Permit (Case No. 9711-02) to allow a restaurant with on-site consumption of general alcohol beverages separate from meal service. Based on the conditions of the CUP that a minimum of twenty-nine (29) parking spaces be maintained on-site, the dance floor was limited to a maximum size of 261 square feet. The limit on the size of the dance floor was reiterated in subsequent reviews of entertainment permit applications in September 2006 and October 2006.

Initially, the current application for entertainment with dancing by patrons requested approval for a 450 square foot dance floor with thirty-two (32) available parking spaces on-site. The request for additional dance floor area could only be approved if there is also an increase of five (5) parking spaces. Planning Bureau recommended that the applicant revise the floor plan reducing the size of the dance floor to meet the available parking on-site.

On this date, the applicant submitted a revised floor plan indicating the dance floor area had been reduced to 231 square feet, measuring 14 feet by 17 feet. As the size of the dance floor is less than the maximum allowed based on the Conditions of Approval for Case No. 9711-02, no additional parking is required.

Planning Bureau recommends that the entertainment permit with dancing for "Hamburger Mary's" be approved.
