1 FIRST AMENDMENT TO AGREEMENT NO. 34652

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 34652 is made and  
4 entered, in duplicate, as of May 30 2019, for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 May 23, 2017, by and between ZONAR SYSTEMS, INC, a Washington corporation  
7 ("Contractor"), with a place of business at 18200 Cascade Ave. S #200, Seattle, WA  
8 98188, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Contractor (the "Parties") entered into Contract No.  
10 34652 ("Contract") whereby Contractor agreed to provide Zonar electronic vehicle  
11 inspection and tracking components including monitoring services; and

12 WHEREAS, the Parties wish to exercise their first option to extend the term  
13 of the Contract;

14 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
15 conditions herein contained, the parties agree as follows:

16 1. Section 3. of Agreement No. 34652 is hereby amended to read as  
17 follows:

18 "3. The term of this Contract shall commence at midnight on July  
19 22, 2017, and shall terminate on July 21, 2020 unless sooner terminated as  
20 provided herein. The City has the option to extend the contract for one (1)  
21 additional period of one (1) year at the discretion of the City Manager, and may  
22 terminate this Contract by giving thirty (30) days prior notice of termination to  
23 Contractor."

24 2. Except as expressly amended in this First Amendment, all terms and  
25 conditions in Agreement No. 34652 are ratified and confirmed and shall remain in full  
26 force and effect.
