3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE AN AGREEMENT WITH RAY
6 GASKIN SERVICE AN AUTHORIZED DISTRIBUTOR FOR
7 NEW WAY TRUCKS AND SCANTON MANUFACTURING
8 COMPANY OF FONTANA, CA, FOR THE PURCHASE OF
9 ONE F-550 FORD TRUCK, WITH RELATED EQUIPMENT
10 AND ACCESSORIES, ON THE SAME TERMS AND
11 CONDITIONS AFFORDED TO SOURCEWELL (FORMERLY
12 THE NATIONAL JOINT POWER ALLIANCE) IN A TOTAL
13 AMOUNT NOT TO EXCEED \$159,903

15 WHEREAS, the Charter of the City of Long Beach (the "City"), Section 1802,
16 permits the City to purchase services, supplies, materials, equipment and labor with other
17 government agencies by purchasing under their contracts on a voluntary and selective
18 basis when authorized by resolution; and

19 WHEREAS, the City desires to purchase one F-550 Ford truck, with related
20 equipment, including 6-yard rear body loader, for use by the Department of Public Works,
21 Clean Team, to support the daily operations removing liter and debris in public rights-of-
22 way, especially supporting programs such as liter abatement, removal of oversized trash,
23 illegally dumped items and special collection services; and

24 WHEREAS, Sourcewell (formerly the National Joint Power Alliance) has a
25 contract with Scranton Manufacturing Company and New Way Trucks under Sourcewell
26 RFP No. 091219 providing the best value to the City for the purchase of one F-550 Ford
27 truck, with related equipment and accessories ("Sourcewell Contract"); and

28 WHEREAS, Ray Gaskin Services is an authorized distributor for Scranton

1 Manufacturing Company and New Way Trucks; and

2 WHEREAS, the City's participation in the Sourcewell Contract will facilitate
3 the City's ability to purchase as well as provide considerable cost benefits to the City; and

4 WHEREAS, if the City had to utilize a formal bid process rather than
5 participate in the Sourcewell Contract, considerably more funds would be required;

6 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
7 follows:

8 Section 1. The above recitals are true and correct and are incorporated
9 herein by this reference.

10 Section 2. The City Manager or designee is hereby authorized to enter an
11 agreement with Ray Gaskin Service, for the purchase of one F-550 Ford truck, with related
12 equipment and accessories, of the same type and kind identified in the Sourcewell Contract
13 except as modified by mutual agreement of the City and Ray Gaskin Service, and the
14 purchase by the City shall be on the same terms and conditions afforded to the Sourcewell
15 in an amount not to exceed One Hundred Fifty-Nine Thousand Nine Hundred and Three
16 Dollars (\$159,903) including taxes and fees.

17 Section 3. This resolution shall take effect immediately upon its adoption
18 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


