1 FIRST AMENDMENT TO AGREEMENT NO. 36094

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 36094 is made and
4 entered, in duplicate, as of April 11, 2023, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on July 6, 2021,
6 by and between ARUP US, INC., a New York corporation, an affiliate of ARUP NORTH
7 AMERICA LIMITED, a United Kingdom corporation ("Consultant"), with a place of business
8 at 77 Water Street, 5th Floor, New York, New York 10005, and the CITY OF LONG BEACH,
9 a municipal corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed professional engineering services ("Project"); and

12 WHEREAS, on July 6, 2021, the City Council adopted Specifications No.
13 RFQ PW0-059 and awarded agreements for as-needed professional engineering services
14 for a period of two (2) years, with the option to renew for three (3) additional one-year
15 periods, at the discretion of the City Manager; and

16 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
17 36094 (the "Agreement") whereby Consultant agreed to provide these services; and

18 WHEREAS, Arup US, Inc., is an affiliate of Arup North America Limited.
19 Effective April 1, 2021, Arup US is the primary operating entity for Arup projects located in
20 the United States; and

21 WHEREAS, the Parties desire to extend the term of the Agreement using the
22 first one-year period option, update the rates sheet in Exhibit B, and update the City's
23 Representative in Exhibit C;

24 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
25 conditions herein contained, the Parties agree as follows:

26 1. Section 2 of the Agreement is hereby amended to read as follows.

27 "2. TERM. The term of this Agreement shall commence at midnight on
28 August 1, 2021, and shall terminate at 11:59 p.m. on July 31, 2024, unless sooner

1 terminated as provided in this Agreement, or unless the services or the Project is
2 completed sooner. The term may be extended for two (2) additional one-year periods, at
3 the discretion of the City Manager.”

4 2. The Rates in Exhibit “B” to the Agreement are hereby amended in
5 accordance with Exhibit “B-1”, attached hereto and incorporated by this reference.

6 3. The City’s Representative in Exhibit “C” to the Agreement is hereby
7 amended in accordance with Exhibit “C-1”, attached hereto and incorporated by this
8 reference.

9 4. Except as expressly modified herein, all of the terms and conditions
10 contained in Agreement No. 36094 are ratified and confirmed and shall remain in full force
11 and effect.


