1 TWELFTH AMENDMENT TO AGREEMENT NO. 33392

3 THIS TWELFTH AMENDMENT TO AGREEMENT NO. 33392 is made and  
4 entered, in duplicate, as of September 18, 2019, for reference purposes only, pursuant to  
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on May  
6 7, 2019, by and between THE RYTE PROFESSIONALS, a corporation ("Consultant"), with  
7 a place of business at 4141 Ball Road, #517, Cypress, California 90630, and the CITY OF  
8 LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.  
10 33392 (the "Agreement") whereby Consultant agreed to provide professional and technical  
11 services for information technology projects and systems; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to  
13 increase the not to exceed amount to \$100,000; and

14 WHEREAS, the Parties entered into a Second Amendment to the Agreement  
15 to increase the not to exceed amount to \$200,000; and

16 WHEREAS, the Parties entered into a Third Amendment to the Agreement  
17 to increase the not to exceed amount to \$400,000 and extend the term to January 22,  
18 2017; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement  
20 to increase the not to exceed amount to \$600,000; and

21 WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to  
22 increase the not to exceed amount to \$900,000; and

23 WHEREAS, the Parties entered into a Sixth Amendment to the Agreement  
24 to increase the total not to exceed amount to \$1,500,000 and extend the term to January  
25 22, 2018; and

26 WHEREAS, the Parties entered into a Seventh Amendment to the  
27 Agreement to increase the total not to exceed amount to \$2,000,000; and

28 WHEREAS, the Parties entered into an Eighth Amendment to the Agreement

1 to increase the total not to exceed amount to \$3,000,000 and extend the term to January  
2 22, 2019; and

3 WHEREAS, the Parties entered into a Ninth Amendment to the Agreement  
4 to increase the total not to exceed amount to \$3,350,000 and extend the term to May 22,  
5 2019; and

6 WHEREAS, the Parties entered into a Tenth Amendment to the Agreement  
7 to increase the total not to exceed amount to \$4,500,000; and

8 WHEREAS, the Parties entered into an Eleventh Amendment to the  
9 Agreement to increase the total not to exceed amount to \$5,000,000 and extend the term  
10 to October 22, 2019; and

11 WHEREAS, the Parties desire to add \$595,000 to the Agreement for a total  
12 not to exceed amount of \$5,595,000;

13 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
14 conditions herein contained, the Parties agree as follows:

15 1. Section 1.A of the Agreement is hereby amended to read as follows:

16 "A. Consultant shall furnish specialized services more particularly  
17 described in Exhibit "A," attached to the Agreement and incorporated by this  
18 reference, in accordance with the standards of the profession, and City shall pay  
19 for these services in the manner described below, a total not to exceed contract  
20 amount of Five Million Five Hundred Ninety-Five Thousand Dollars (\$5,595,000),  
21 at the rates or charges shown in Exhibit "A".

22 2. Except as expressly modified herein, all of the terms and conditions  
23 contained in Agreement No. 33392 are ratified and confirmed and shall remain in full force  
24 and effect.




