SUBJECT: Public Walkways Occupancy Permit for Sidewalk Dining at Steak-O-Rama Restaurant Located at 5201 East Second Street (District 3)

DISCUSSION

Steak-O-Rama, Inc., the operator of the Steak-O-Rama Restaurant, requested a first time permit to temporarily occupy a part of the adjoining sidewalk at 5201 East Second Street with portable fixtures for the purpose of sidewalk dining. The proposed permit area and a list of furnishings and accessories are shown on the attached Exhibit A. Approval of this permit is based on the conditions and standards of Chapter 14.14 of the Long Beach Municipal Code, which describes temporary uses of public rights-of-way. The width of the sidewalk at this location is 13.5 feet and there are no street fixtures between the permit area and the curblineline that will obstruct the remaining 9 feet of right-of-way.

The subject permit was prepared by Deputy City Attorney Lisa Peskay Malmsten on January 26, 2004.

TIMING CONSIDERATIONS

City Council action on this matter is not time critical.

FISCAL IMPACT

A permit processing fee of \$500 was deposited to the General Fund (GP 100) in the Department of Public Works (PW).
