1 FIFTH AMENDMENT TO AGREEMENT NO. 34663

3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 34663 is made and
4 entered, in duplicate, as of June 7, 2023, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on June 6, 2023,
6 by and between WESTGROUP DESIGNS, INC., a California corporation ("Consultant"),
7 with a place of business at 19520 Jamboree Road, Suite 100, Irvine, CA 92612, and the
8 CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 34663 (the "Agreement") whereby Consultant agreed to provide as needed urban planning
11 design services for a period of two (2) years with the option to renew for three (3) additional
12 one-year periods in an amount not to exceed Six Hundred Thousand Dollars (\$600,000);
13 and

14 WHEREAS, the Parties entered into a First Amendment to increase the
15 contract amount for a total not to exceed Eight Hundred Thousand Dollars (\$800,000), and
16 extend the term of the Agreement to June 30, 2020; and

17 WHEREAS, the Parties entered into a Second Amendment to increase the
18 contract amount for a total not to exceed Nine Hundred Thousand Dollars (\$900,000), and
19 extend the term to June 30, 2021; and

20 WHEREAS, the Parties entered into a Third Amendment to extend the term
21 of the Agreement to June 30, 2022; and

22 WHEREAS, on June 21, 2022, City Council approved extending the
23 Agreement one (1) additional one-year period; and

24 WHEREAS, the Parties entered into a Fourth Amendment to extend the term
25 to June 30, 2023, update the City Representative, and attach an updated rate sheet; and

26 WHEREAS, on June 6, 2023, City Council approved to extend the term of
27 the Agreement by one (1) additional one-year period; and

28 WHEREAS, the Parties desire to extend the term of the Agreement using the

1 authorized one-year period;

2 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
3 conditions herein contained, the Parties agree as follows:

4 1. Section 2 of the Agreement is hereby amended to read as follows:

5 "2. TERM. The term of this Agreement shall commence at midnight on
6 July 1, 2017, and shall terminate at 11:59 p.m. on June 30, 2024, unless sooner terminated
7 as provided in this Agreement, or unless the services or the Project is completed sooner."

8 2. Except as expressly modified herein, all of the terms and conditions
9 contained in Agreement No. 34663 are ratified and confirmed and shall remain in full force
10 and effect.






