

1 THIRD AMENDMENT TO CONTRACT NO. 34416

3 THIS THIRD AMENDMENT TO CONTRACT NO. 34416 is made and
4 entered, in duplicate, as of February 2, 2021 for reference purposes only, pursuant to
5 Resolution No. RES-16-0073, adopted by the City Council of the City of Long Beach at its
6 meeting on November 17, 2020, by and between KOPPL PIPELINE SERVICES, INC., a
7 California corporation ("Contractor"), with a place of business at 1228 Date Street,
8 Montebello, California 90640 , and the CITY OF LONG BEACH ("City"), a municipal
9 corporation.

10 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
11 34416 (the "Contract") pursuant to Resolution No. RES-16-0073 whereby Contractor
12 agreed to provide pipeline stopper fittings and tapping and stopping services for natural
13 gas pipelines greater than 12-inches in diameter; and

14 WHEREAS, the Parties entered into a First Amendment to the Contract to
15 extend the term to October 1, 2019; and

16 WHEREAS, the Parties entered into a Second Amendment to the Contract
17 to extend the term to October 1, 2020; and

18 WHEREAS, the Parties desire to extend the term one (1) additional one-
19 year period and add the authorized annual amount of \$400,000;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants and
21 conditions herein contained, the Parties agree as follows:

22 1. Section 3 of the Contract is hereby amended to read as follows:

23 "3. The term of this Contract shall commence on October 1, 2016, and
24 shall terminate at midnight on October 1, 2021 unless sooner terminated as provided
25 herein. The City may terminate this Contract by giving thirty (30) days prior notice of
26 termination to Contractor."

27 2. Except as expressly modified herein, all of the terms and conditions
28 contained in Contract No. 34416 are ratified and confirmed and shall remain in full force

1 and effect.
