SECOND AMENDMENT TO MANAGED CARE SERVICING AGREEMENT NO. 28996

The first extended term of this Agreement shall begin on November 1, 2005, and shall end on October 31, 2006 (both days inclusive), unless terminated earlier in accordance with Section 13. The second extended term of this Agreement shall begin on November 1, 2006, and shall end on October 31, 2007 (both days inclusive), unless terminated earlier in accordance with Section 13."

2. Except as expressly amended in this Second Amendment, all terms and conditions in the Agreement are ratified and confirmed and shall remain in full force and effect.
