3 THIS SECOND AMENDMENT TO MANAGED CARE SERVICING
4 AGREEMENT NO. 28996 is made and entered, in duplicate, as of October 9, 2006 for
5 reference purposes only, pursuant to a minute order adopted by the City Council of the City
6 of Long Beach at its meeting on December 14, 2004, by and between TRISTAR
7 MANAGED CARE, INC. ("Tristar") and the CITY OF LONG BEACH ("Client").

8 WHEREAS, the Agreement provides that Tristar will provide medical bill
9 review and case management services to City; and

10 WHEREAS, the Agreement further provides that the parties may mutually
11 agree to extend the term and they desire to do so;

12 NOW, THEREFORE, in consideration of the mutual terms and conditions in
13 the Agreement and herein, the parties agree as follows:

14 1. Section II of the Agreement is hereby amended in its entirety to read as
15 follows:

16 "II. EFFECTIVE DATE AND TERM

17 "The initial term of this Agreement shall begin on November 1, 2004, and
18 shall end on October 31, 2005 (both days inclusive), unless terminated earlier in
19 accordance with Section 13. The first extended term of this Agreement shall begin on
20 November 1, 2005, and shall end on October 31, 2006 (both days inclusive), unless
21 terminated earlier in accordance with Section 13. The second extended term of this
22 Agreement shall begin on November 1, 2006, and shall end on October 31, 2007 (both
23 days inclusive), unless terminated earlier in accordance with Section 13."

24 2. Except as expressly amended in this Second Amendment, all terms and
25 conditions in the Agreement are ratified and confirmed and shall remain in full force and
26 effect.
