SEVENTH AMENDMENT TO AGREEMENT NO. 35451

35451

THIS SEVENTH AMENDMENT TO AGREEMENT NO. 35451 is made and entered, in duplicate, as of March 14, 2023, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on December 8, 2020, and March 7, 2023, by and between DELOITTE CONSULTING LLP, a Delaware limited partnership ("Consultant"), with a place of business at 655 W. Broadway, Suite 700, San Diego, California 92101, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 35451 (the "Agreement") whereby Consultant agreed to provide implementation services for a Customer Relationship Management (CRM) system; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to clarify the Scope of Work; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to December 31, 2021, add the authorized annual amount plus ten percent (10%) of the contingency amount and update the Scope of Work; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to update the Scope of Work; and

WHEREAS, the Parties entered into a Fourth Amendment to the Agreement to add an annual amount of \$240,000; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to update the Scope of Work; and

WHEREAS, the Parties entered into a Sixth Amendment to extend the term to December 31, 2022 and add the authorized annual amount of \$300,000; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add the annual authorized amount of \$264,000, and contingency of \$66,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and

1 conditions herein contained, the Parties agree as follows:

2 1. Section 1.A. of the Agreement is hereby amended to read as follows:

3 "A. Consultant shall furnish specialized services more particularly
4 described in i) the Scope of Work, attached to this Agreement and incorporated by
5 this reference as Exhibit "A-1", and ii) Consultant's response to City's Request for
6 Proposals Number TI 18-063, attached to the Agreement and incorporated by this
7 reference as Exhibit "A-2"; and in accordance with the standards of the profession,
8 City shall pay for these services in the manner described below, in an amount of
9 One Million Six Hundred Fifty Thousand Dollars (\$1,650,000), with a ten percent
10 (10%) contingency in the amount of One Hundred Sixty-Five Thousand (\$165,000)
11 Dollars for a total amount not to exceed One Million Eight Hundred Fifteen Thousand
12 Dollars (\$1,815,000) for the term January 1, 2020 through December 31, 2020; and
13 an annual amount of Two Hundred Forty Thousand Dollars (\$240,000), with a
14 twenty-five percent (25%) contingency in the amount of Sixty Thousand Dollars
15 (\$60,000) for a total not to exceed annual amount of Three Hundred Thousand
16 Dollars (\$300,000) for the term January 1, 2021 through December 31, 2022; and
17 an annual amount of Two Hundred Sixty-Four Thousand Dollars (\$264,000), with a
18 twenty-five percent (25%) contingency in the amount of Sixty-Six Thousand Dollars
19 (\$66,000) for a total not to exceed annual amount of Three Hundred Thirty
20 Thousand Dollars (\$330,000) for the term January 1, 2021 through December 31,
21 2023, at the rates or charges shown in Exhibit "B"."

22 2. Section 2 of the Agreement is hereby amended to read as follows:

23 "2. TERM. The term of this Agreement shall commence at midnight on
24 January 1, 2020, and shall terminate at 11:59 p.m. on December 31, 2023, unless sooner
25 terminated as provided in this Agreement, or unless the services or the Project is
26 completed sooner."

27 3. Except as expressly modified herein, all of the terms and conditions
28 contained in Agreement No. 35451 are ratified and confirmed and shall remain in full force
