

RESOLUTION NO. RES-07-0163

A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF LONG BEACH AUTHORIZING THE CITY
MANAGER TO ACQUIRE SIX (6) BMW POLICE
CERTIFIED MOTORCYCLES THROUGH THE CONTRACT
BETWEEN THE STATE OF CALIFORNIA AND LONG
BEACH BMW

WHEREAS, the Charter of the City of Long Beach (the "City"), Section
1802, permits the City to purchase services, supplies, materials, equipment and labor
with other government agencies by purchasing under their contracts on a voluntary and
selective basis when authorized by resolution; and

WHEREAS, the City desires to purchase six (6) BMW police certified
motorcycles, with the option to purchase additional BMW police certified motorcycles;
and

WHEREAS, the State of California has a contract for the purchase of these
motorcycles from Long Beach BMW, Contract No. 1-07-23-30 ("State Contract"); and

WHEREAS, the City's participation in the State Contract will facilitate
acquisition of these motorcycles as well as provide considerable cost benefits to the City;
and

WHEREAS, if the City had to go to formal bid rather than participate in the
State Contract considerably more funds would be required;

NOW, THEREFORE, the City Council of the City of Long Beach resolves as
follows:

Section 1. The above recitals are true and correct and are incorporated
herein by this reference.

Section 2. The City Manager of the City is hereby authorized to enter an

1 agreement with Long Beach BMW to purchase six (6) BMW police certified motorcycles,
2 with the option to purchase additional BMW police certified motorcycles, of substantially
3 the same type and kind purchased by the State of California pursuant to the State
4 Contract except as modified by mutual agreement of the City and Long Beach BMW, and
5 the purchase by the City shall be on the same terms and conditions afforded to the State
6 of California in an amount not to exceed \$134,115.26, including tax, with a 10%
7 contingency for additional equipment, for a period extending until the warranty on the
8 motorcycles expire.


9 Section 3. This resolution shall take effect immediately upon its adoption
10 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
