RE: City Council item#27... Public Access TV... "PEG" funds

- I have had the honor of representing Long Beach Community Television as Supervisor for the past 7 years. I
 was employed by Charter Communications through the Franchise agreement with the City.
- I reported to the City at Quarterly CABLE COMMISSION MEETINGS hosted by the Video Communications
 Dept. officer, Dean Smits.
- l've been amazed at the citizen response to our public access. It has grown from 50 volunteer producers to over 100 and was continuing to grow at the rate of 5 new volunteer producers at each monthly training workshop. We have consistently produced 3 new programs each day and 90 per month. We did broadcast over 2000 hours of programming per year and our Community Calendar announced upcoming events and outreach programs with contact information from 9PM to 1:00PM each day.
- Our production crew members were creative & talented with excellent technical skills and dedicated to
 making the community better. Most all <u>crew members were graduates from the Long Beach City College
 vocational TV Production/Broadcast program.</u> They too, were paid through Charter Communications via the
 Franchise agreement with the City. After years of service and established relationships with the diverse
 producers, they are now unemployed and the talents and skills that they shared with this community are not
 being used.
- The Long Beach City Prosecutor, Tom Reeves has produced, "Letter of the Law" 2 times a month for the past 10 years.
- Vice Mayor Val Lerch has produced his "North Long Beach Report" monthly for the last several years.
- Councilwoman Gerrie Schipske has had her own program in previous years.
- Our volunteer producers have covered "Long Beach Reads One Book", "Tour Des Artists", "Smithsonian Week", "Children's Day", "Principal for a Day", candidates forums, school performances, community festivals and more...
- We have hosted <u>regular</u> interviews with our school superintendent; University President, F King Alexander; numerous dignitaries including international "Sister City" officials; health, spiritual outreach and finance experts.
- We have programs produced by the <u>handicapped</u> for the <u>handicapped</u>.
- Traditional TV ACCESS is important to the handicapped community as well as to the SENIORS and those
 who do not have computer skills and/or access.
- "R U Talented" has been providing a venue for Long Beach's talented kids since long before the network's
 "American Idol" and "America's Got Talent".
- Our representation of the diversity of our city is unmatched.
- We have Cambodian, Spanish, Samoan language programs as well as LIVE NEWS programs from/for the gay and lesbian community as examples.
- Over 500 culturally diverse community members would sign in to our guest list each month.
- That means that over 500 community members had a chance to exchange their ideas and share their art & cultural traditions, outreach programs, forums, workshops, festivals and entertainment via cable television.
- 5 years ago on the occasion of our 20th Anniversary, then Mayor Beverly O'Neil gave us a Proclamation from the City attesting to our value, and then State Senator Betty Karnette awarded us a State Commendation.
- This year would be our 25th year.
- 25 Years ago the City of Long Beach made a decision to create Public Access Television.....with the

Why does Long Beach Public Access need PEG funds?

- Public access is the only entity which has been affected negatively by the new legislation (CA AB 2987). Studio and station channel were shut down Jan 2009.
- 25 year History, continuity of programming
- Legacy of Established Diverse Cultural Community Connections
- History of connections to neighborhood resources/organizations/events & festivals
- Public Access has provided an access to media where the <u>politically and culturally diverse</u> VOICES of the community

 and he beard.
- These connections to the community have strengthened the cultural fabric of Long Beach, which promotes more
 peaceful neighborhoods and encourages increased participation in the democratic process.

Without public access to media;

- The people's voice cannot be heard, necessary for a thriving Democracy
- Exchange of ideas does not happen,
- There is no forum for presentation
- There is no community of viewers having the common experience of learning about the people who make up the city
 of Long Beach.
