**Subject:** Funding Support for 6<sup>th</sup> Annual Touch-A-Truck Event

**RECOMMENDATION:**

Increase appropriations in the Special Advertising and Promotion Fund Group in the City Manager Department by \$5,555, offset by the Third Council District One-time District Priority Funds transferred from the Citywide Activities Department to provide a donation to Community Action Team for the Touch-A-Truck Event; and,

Decrease appropriations in the Special Advertising and Promotion Fund Group in the Citywide Activities Department by \$5,555 to offset a transfer to the City Manager Department.

**INTRODUCTION:**

On March 28, 2020 the Community Action Team will be partnering with the Third Council Office to host the 6<sup>th</sup> annual Touch-A-Truck event at the Granada Beach Parking Lot from 9:30 AM to 1:00 PM. This is a community focused event that brings families together in a positive way to learn about and experience a variety of vehicles and equipment. This event will take place at one of the City's local beaches, calling attention to the City's natural resources.

As part of the FY 20 Adopted Budget, the City Council allocated \$235,000 of Special Advertising and Promotions Fund Group (SAP) funds available to be divided equally between the City Council Districts to be used towards SAP-qualified special events or contributions, managed by the Office of Special Events and Filming in the City Manager Department. This recommendation is requesting that \$5,555 of the Third Council District One-time SAP District Priority Funds be allocated for this special event

This matter was reviewed by Budget Manager, Grace H. Yoon on March 4, 2020.

**FISCAL IMPACT:**

This recommendation requests the City Manager Department to provide a payment to Community Action Team in support of Touch-A-Truck. The total appropriation increase in the Special Advertising and Promotion Fund Group in the City Manager Department by \$5,555 is offset by a decrease of appropriation of Third Council District one-time District Priority Funds in the Special Advertising and Promotion Fund Group in the Citywide Activities Department. The requested action is anticipated to require a minimal level of staff hours beyond the budgeted scope of duties and is expected to have a minimal impact on existing City Council priorities.

The event is scheduled for March 28, 2020 and funding is sought prior to the event.


