1 FIRST AMENDMENT TO AGREEMENT NO. 35115

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 35115 is made and
4 entered, in duplicate, as of November 1, 2020, for reference purposes only, pursuant to
5 Resolution No. RES-18-0150, adopted by the City Council of the City of Long Beach at its
6 meeting on October 2, 2018, by and between ZOLL MEDICAL CORPORATION, a
7 Massachusetts corporation ("Contractor"), with a place of business at 269 Mill Road,
8 Chelmsford, Massachusetts 01824, and the CITY OF LONG BEACH ("City"), a municipal
9 corporation.

10 WHEREAS, City and Contractor (the "Parties") entered into Agreement No.
11 35115 (the "Agreement") whereby Contractor agreed to provide to the Long Beach Fire
12 Department additional units, parts and accessories compatible with their 12-lead
13 electrocardiogram defibrillator units; and

14 WHEREAS, the Parties desire to extend the term one additional one-year
15 period;

16 NOW, THEREFORE, in consideration of the mutual terms and conditions
17 contained herein the Parties agree as follows:

18 1. Section 3 of the Agreement is hereby amended to read as follows:

19 "3. The term of this Contract shall commence on November 1, 2018, and
20 shall terminate at midnight on October 31, 2021, unless sooner terminated as provided
21 herein. The Parties have the option to extend the term for two (2) additional one-year
22 periods. The City may terminate this Contract by giving thirty (30) days prior notice of
23 termination to Contractor."

24 2. Except as expressly modified herein, all of the terms and conditions
25 contained in Agreement No. 35115 are ratified and confirmed and shall remain in full force
26 and effect.
